#### **TENDER NOTICE**

NAME OF WORK: Repair and renovation of gents toilet at 23<sup>rd</sup> floor and distempering including polishing of ceiling and partitions in JVB, New Delhi

Sealed item rate tenders in two separate envelops (i.e. TECHNICAL AND FINANCIAL BIDS) are invited from the contractors who have executed similar type of works i.e. civil, sanitary and finishing works in CPWD, PWD, MCD, DDA, P&T, PSU's, Semi-Govt. departments, MNC's. Documents from clients to be attached. The works carried out by the party should not be less than Rs. 1,59,000/- per annum in single award or having two similar works not less than Rs. 99,500/- or three similar works not less than Rs. 79,600/- each per annum during the last seven years.

Sealed tenders based on this notice and terms & conditions and Schedule of Quantities attached along with a Cross Bank Draft for Rs. 5,000/- in favour of 'The State Trading Corporation of India Ltd.' Towards interest free EMD should be furnished and put in the Tender Box kept at Ground Floor (Reception), Jawahar Vyapar Bhawan, Tolstoy Marg, New Delhi – 110 001 on 24.02.2015 by 3.00 PM. Tender delivery by post or by Courier shall be summarily rejected. Only tenders dropped in the Tender Box shall be considered. The tender's Technical Bids shall be opened at 3.30 PM on the same day at the same place, in the presence of tenderers who may wish to be present The tender without requisite Earnest Money shall be summarily rejected. The Earnest Money deposit of the unsuccessful tenderers shall be refunded within a month of award of work and no interest will be paid on it.

STC, reserves the right to accept, cancel or reject any or all the tenders without assigning any reasons thereof. No Tenderer shall have any cause of action/claim against STC for rejection of his proposal.

All corrections/overwriting made while filling the quotations must be authenticated by the tenderer.

Each page of tender document is required to be signed by the tenderer in token of his/their having acquainted himself/themselves with the Tender Notice and Terms & Conditions. The rates quoted in the tender should be firm and for all heights and levels except where it has been mentioned specifically and inclusive of all charges of materials, scaffolding, tools and plants, labour and fluctuations in the market rates, VAT, Service Tax, sales tax, excise duty, octroi and other taxes etc.

Quantities mentioned in the schedule are approximate and subject to change. No compensation will be paid on account of reduction in quantity of any item of work. Payment shall be made on actual executed quantity. The quoted rates are valid for the actual quantities of work executed. No escalation on any account shall be paid on the quoted rates during the period of contract and also during the duly sanctioned extension of time, if any.

The work shall not be considered as complete until the Engineer Incharge, STC has certified in writing that the same has been virtually completed and defect liability period shall commence from the date of issue of such certificate. Virtual completion certificate will not be issued until the contractor shall clear the site of all malba, scaffolding, surplus materials and huts etc. and remove all dirt and dust from the site.

The contractor shall acquaint himself with the site conditions and make his own arrangements for storage of materials at site. No material shall be supplied departmentally.

The quantity and quality of materials to be used shall be got approved from the Engineer Incharge, STC before execution of work. The contractor will rectify the defects pointed out to him by Engineer Incharge, STC and shall remove from the site all the rejected materials immediately.

The contractor will be fully responsible for any injury or accident to any person(s) employed by him, to the residents and for any damage/loss to any structure or any part of the property which may arise due to operation/negligence of the contractor of its workers while executing the work, at his own cost repair and make good the same.

The contractor, at his own cost, shall obtain Third Party Insurance Policy & Workmen Compensation Policy in joint name of STC Of India Ltd., and contractor with STC's name appearing first for the appropriate value, which shall remain valid till the completion of work.

# TDS, WCT and Service Tax as applicable thereon will be deducted from the running account bills/final bill as per prevailing rates.

The rates quoted by the tenderers shall be valid for acceptance for a period of **90 days** from the date of opening of the tender.

The rates shall be quoted only in the Bill of Quantity and each page of tender shall be signed. Any cutting or overwriting shall be initialed.

While quoting the rates, the word "only" should be written closely following the amount and it should not be written in the next line.

The tenderer should not arrange witness on tender form, from a person who has tendered for the same work.

The tenderer shall not assign, transfer and sublet or otherwise parts with the work or any portion of the work to other contractor, without prior written approval of STC.

No condition/deviation which is either additional or in modification of tender conditions shall be included in the bid/tender submitted by the tenderer. If the tenderer contains any such condition on deviation from the tender conditions, the tender will be rejected. STC's decision in this regard shall be final and binding.

In the event of the tender being submitted by a partnership firm, it must be signed separately by each partner thereof, and further it must also disclose that the firm is duly registered under the Indian Partnership Act, 1932.

The contractor upon award of the work shall comply with all the required statutory provision/regulations e.g. Payment of Wages Act, Minimum Wages Act, Employees Liability Act, Apprentice Act, Workmen's Compensation Act, Contractor's Labour (Regulation & Abolition) Act, Industrial Disputes Act, Maternity Benefit Act, etc. or any other laws relating thereto and the rules made there under from time to time and the rates made there under from time to time and also as per safety regulations at their own cost & risk. If any claim, on account of non-compliance of the above laws by the contractor arises against the STC, the tenderer shall indemnify and keep indemnify the STC. The Engineer Incharge, STC shall have the right to deduct from the money due to the contractor any sum required or estimated to be required for making good the loss suffered by a worker or workers.

The tender documents can be purchased from Shri B.S.Bhamra, Chief Manager (Civil) at 20<sup>th</sup> Floor, Jawahar Vyapar Bhawan, New Delhi, on any working day between 11.00 AM to 4.00 PM on payment of a non-refundable fee of Rs. 500/- in the shape of Demand Draft in favour of "STC Of India Ltd.", payable at New Delhi, up to 23.02.2015.

The tenderers are advised to inspect the site and satisfy themselves of site conditions before submitting their tenders. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent upon any misunderstanding or otherwise shall be allowed.

#### **TERMS & CONDITION**

NAME OF WORK: Repair and renovation of gent's toilet at 23<sup>rd</sup> floor and distempering including

polishing of ceiling and partitions in JVB, New Delhi

The following are the terms & conditions for the above mentioned work:-

1. The work will be executed strictly as per specifications by the contractor to the entire satisfaction of the Engineer Incharge, STC and time period of completion will be **30 days** to be reckoned from the 7<sup>th</sup> day of the date of written order from the STC to the contractor to commence the work.

The contractor, before commencing the work, shall prepare a detailed work programme, which will be approved by STC.

In case, the successful tenderer does not commence the work by stipulated date in terms of Award Letter, STC shall without prejudice to any other right/remedy, be at liberty to forfeit the said EMD absolutely in addition to recovery of other damages/losses caused to STC on this account. The party shall also be Black Listed for participation in all subsequent tenders.

#### 2. SECURITY DEPOSIT

Security Deposit @ 10% will be deducted from the bills of contractor and no interest will be paid on the above amount.

- (I) The Earnest Money Deposited by the successful tenderer along with the tender shall be adjusted against the Security Deposit.
- (II) Total security deposit as deducted on the above basis shall be refunded without interest by STC after **six month** of the date of completion of the work and after due certification by Engineer Incharge, STC that no defects have been noticed in the work.
- 3. If the contractor desires an extension of time of completion of the work on the grounds of having been unavoidable hindrance in its execution or any other ground, he shall forthwith give written notice of cause of delay to the Engineer Incharge, STC about the hindrance on account of which he desires such extension as aforesaid and the General Manager (BP&MD), STC shall authorize such extension of time as may in his opinion be necessary and proper. No application for extension of time shall be considered by STC under this clause unless it is made by the contractors before scheduled date of completion of work.
- 4. If the contractor fails to complete the work in time including approved extended time period of completion, penalty/liquidity damage for non-completion of the work @ 1% of the contract value for each day of delay including holidays subject to maximum of 10% of the contract value of work shall be recovered. The decision of STC in this regard, shall be final and binding on the contractor.

- 5. STC may at its discretion, change or alter any specifications or design during the course of execution of the work and the contractor shall have no objection to the same.
- 6. The contractor shall execute an agreement on non-judicial stamp paper of Rs. 100/- within one week's time from the date of issue of award work as per approved proforma. The cost of stamp paper shall be borne by the party. This notice of tender shall form a part of the contract agreement.
- 7. All payments to the contractor shall be released by STC on the basis of work and amount certified by Engineer Incharge, STC.
- 8.. The contractor shall submit the bills in duplicate, giving complete description of items of work done strictly as per Bill of Quantities.
- 9. The rates quoted shall be inclusive of all the taxes viz **VAT**, **WCT**, **etc.**, for all tools and plants and everything necessary for proper execution of work to the entire satisfaction of STC and no escalation due to increase in price of materials/labour shall be made.
- 10. The Contractor shall fully indemnify and keep indemnified STC of India against any type of action/claim, loss/accident/damage, cost expenses or otherwise caused due to the negligence & default on the part of contractor and he should take all such/adequate precautions for smooth execution of the work.
- 11. In the event of any disputes/differences arising over the construction/effect of these presents, decision of Chief General Manager (P&A.), STC will be treated as final and binding on both the parties.
- 12. The Contractor shall make his/their own arrangements for water and power supply for execution of work. In case water and electricity is supplied by the STC, 1% for each i.e. water & electricity totaling to 2% of the bill amount will be recovered from the contractor.
- 13. The ex-employee of the Corporation i.e. STC is/are not permitted to participate in the tender/quotation.
- 14. The terminated/de-barred/Black Listed bidder from any Govt./Semi-Govt/Private/ PSUs/MNCs etc. are not allowed to participate in the said tender. The tenderer has to produce self attested certificate in this regard. If the bidder deliberately gives wrong information in his tender, the bid is liable to be rejected at any stage and the Security Deposit and/or EMD/dues to STC shall be forfeited.
- 15. It is intention of STC that all payments to the contractor shall be effected by EFT.
- 16. On satisfactory completion of 23<sup>rd</sup> floor toilet, Management reserves its right to award contract for similar renovation of toilets in other toilets at JVB under the same rates, terms & conditions.

- 17. The tenderer shall seal the tender in two envelopes duly marking on the envelopes as under:-
  - (A) First envelope shall be marked "Technical Bid" along with the following details in the envelope:
    - (i) EMD of Rs. 5,000/-.
    - (ii) Tender documents duly stamped & signed,
    - (iii) Experience certificate, supporting documents etc. Experience Certificate should clearly mentioned the name & nature of work, place of work, value of work executed, satisfactory performance of work and date of completion of work etc.
    - (iv) Name, Telephone Numbers and address of the contractor.
    - (v) DD/Pay Order of Rs. 500/- towards documents cost, if downloaded from STC/Govt. website.
    - (vi) Self attested Certificate regarding Clause 14 of Terms & Conditions.
    - (vii) Copy of Registration/Certificate of PAN Card, Copy of Registration/Certificate of TIN & Service Tax Number.
    - (viii) In case of Partnership firm, Copy of Partnership Deed may be attached.
  - (B) Second envelope marked as "Financial Bid" for
    - (i) Tender's Schedule of Quantity duly stamped and signed.
    - (ii) Name, Telephone Numbers and address of the contractor.
- 18. The first envelope shall contain the Technical Bid, Earnest Money Deposit and all the prequalification documents required for eligibility experience and qualification whereas the second envelop shall contain only the Financial Bid clearly marked in bold letters as 'FINANCIAL BID'. First envelope shall be opened on **24.02.2015** at **3.30 PM** and the second envelope containing 'FINANCIAL BID' of only those tenderers who have qualified in the technical bid shall be opened after pre-qualification of the tenderers. The date and time of opening the price bids shall be intimated to the pre-qualified tenderers later on.
