THE STATE TRADING CORPORATION OF INDIA LTD., A Govt. of India Enterprise under the administrative control of the Ministry of Commerce & Industry, New Delhi invites bids from Multi-Mode Transport Operators for undertaking job of handling, clearing, container stuffing, transportation, stevedoring and loading of Red Sander on vessel from Cochin Port for export from India on behalf of Directorate of Revenue Intelligence (DRI), Govt of India. The stocks of Red Sanders are in the possession of DRI and stored at seven locations around Cochin, Kerala and one location in Pollachi, Tamil Nadu.

A) **QUALIFICATION CRITERIA FOR BIDDERS:**

The bidder should fulfill the below mentioned criteria:

a) Technical:

- i. The bidder should be a Multi-Mode Transport operator Registered with D.G. Shipping and a member of Federation of Freight Forwards Association of India (FFFAI having valid CHA license.
- ii. Should have handled goods worth Rs.25 Crores during each of last 3 Financial Years.
- iii. The bidders should have sound and covered bodytrucks/lorries for safe transportation of Red Sanders.
- iv. The bidder should be fully conversant with custom formalities and possess required approvals/licenses from Port Authorities for cargo clearing, handling and stevedoring jobs, registered in India as Indian Company.

b) **Financial:**

- i. The bidder should have positive net worth of atleast Rs.1 Crore at the time of submission of Bid.
- ii. Should have minimum annual turnover of **Rs.3 Cr.** during the previous year Or **Rs.10 Cr.** cumulative during last 3 years.

B) SCOPE OF WORK:

a) The cargo is stock of Red Sanders, a precious wood, in possession of DRI and lying at (i) Kerala State Warehousing Corporation, Eroor, Cochin (ii) M/s Falcon CFS, Kalamasserry, Cochin (iii) M/s.Gateway Distriparks CFS, Vallarpadam, Cochin (iv) EDC Building, Willington Island, Cochin (v) Central Excise, Pollachi. The secured transportation of cargo is the essence of the services provided by the Agency. The Agency shall act as a Multi-Mode Transport operator cum Custom House Agent on behalf of STC, make arrangements to receive/take delivery of goods on behalf of STC from nominated godowns and coordinate all activities after receipt of Delivery Order, till shipment of goods. The Agency will ensure that only approved goods are transported and loaded. Such agency will take appropriate comprehensive insurance of the goods so handed over by STC of India Ltd. from the nominated godowns till loading of cargo on the authorized vessel/container(s).

- b) The weighment shall be recorded for each truck by the Agency and proof thereof shall be produced to STC, as and when demanded. STC shall have the right to nominate its officials/or their representative to supervise the operations.
- c) The Agency shall accept full responsibility for safety and security of the cargo and any act of theft, shortage, criminal misappropriation and breach of trust in respect of goods entrusted to the Agency by any such event. The Agency shall be fully responsible and indemnify STC for any loss, damage or pilferage to the goods, claim of whatsoever nature because of improper storage and handling of stock on behalf of STC. The compensation for loss/damage shall be payable to STC at the rate as ascertained by STC.
- d) The Agency shall not hypothecate or mortgage or create any Lien/Agency charges whatsoever on the goods received by them on behalf of STC. The Agency shall also have no right to withhold the delivery of the goods in any circumstances for whatever reason irrespective of any of their part-claim.
- e) It shall be the responsibility of the Agency to make all arrangements like providing adequate labour, supervisors and other necessary equipments/tools, required for lifting the goods from the designated godowns till containerization and loading onto the vessel.
- f) STC's buyers would be nominating vessels. The Agency has to make necessary arrangements of equipments such as crane, hooks, grab etc. for loading material onto the vessels.
- g) For non-delivery or short delivery of the consignments, STC shall reserve the right to impose penalty at the rate to be determined by it from time to time in addition to recovering the cost of the material. Such determination of penalty by STC shall be final and binding on the Agency.
- h) It shall be the sole responsibility of Agency to protect the goods from damages, during transportation, stacking and loading onto the ship. The Agency shall maintain a proper account of quantity lifted from each godown and submit report to STC.
- i) At the time of shipment, the Agency shall arrange safe transportation of containers from designated godown within port premises after pre-inspection, survey and weighment to wharf for effecting shipments through containers/bulk.
- j) In case of shipment of goods in bulk, full details of the quantity of Red Sanders shall be kept by the Agency shipment-wise. Any shortage will be to the account of Agency and STC shall have the right to recover such amount from the bills payable to the Agency.
- k) The Agency shall arrange to prepare and immediately file with concerned authorities all documents like shipping bill, GR form, invoices, obtain custom clearance, arrange pre-shipment

survey, sampling/weighment, etc. and obtain Clean / Shipped on Board Bill of Lading upon shipment. Any Agency charges/expenses in this regard are to be borne entirely by Agency. Any amendments required in the documents shall be carried out by the Agency at their own cost. The Agency shall be held fully responsible for any loss to STC on account of discrepancy in documents and the same shall be rectified by the Agency immediately and STC to be informed accordingly.

- 1) The Agency shall prepare all shipping documents strictly as per the terms of Letter of Credit such as Certificate of Origin, Inspection Certificate, Packing List including Certificate from NBA etc. and shall be responsible for timely dispatch (within two days after shipment) of same to STC's nominated Branch offices. In case of any delay in the dispatch of documents, Agency shall bear the interest loss due to delay in negotiation/realization of the export proceeds.
- m) Agency shall keep valid license granted to him by Customs / Port Authorities till the completion of the contract, if awarded.
- n) Agency will be required to perform all duties prescribed under Custom Act & Custom House Regulations as amended from time to time.
- o) Agency shall keep themselves fully conversant and familiar with the laws, rules, regulations and procedures framed by Port Trust, Customs, DGFT and other concerned authorities for clearance and carriage of goods by Sea/ Rail/ Road.
- p) The bidder shall be responsible for employing suitable labour/ worksmen at the site as per the prevailing labour laws of India and STC shall not be responsible for any claims arising due to any mis-happening/accident of workmen deployed by the agency for Transportation of Red Sanders. It shall also be the sole responsibility of the bidder to protect Red Sanders from any damages during the transportation.
 - Bidders shall not assign, transfer, and sublet the work / obligations without prior written permission of STC.
 - Receive/taking delivery of goods on behalf of STC from nominated godowns and coordinate all activities after receipt of Delivery Order, including identification of stocks with inspection agencies/ Agency's representative.
 - Recording of all the goods received & shipped.
 - Transportation of approved goods from designated Depots on lot /MTs basis.
 - Stuffing into containers and movement to ICD/Port.
 - Custom documentation, clearing, handling and arranging all pre-cargo & post shipment, shipping documents as mentioned in the Contract.
 - Loading into vessel including terminal handling Agency charges (In Containers).
 - Insurance coverage from the dispatch point till shipment (stock and transit insurance)

All offers shall be submitted online along with the scanned copy of RTGS/NEFT transaction details towards EMD payment. EMDs paid by Cheques/DD/Pay Order are not acceptable.

The EMD are waived for Micro Small and Medium Enterprises (MSME). The valid MSME certificate issued by Competent Authorities as notified per the guidelines of Ministry of Micro Small & Medium Enterprises, Government of India need to be uploaded in the portal during the participation in the tender for claiming the said waivers.

In event of failing to pay the EMD by Bidders/Agency and non submission of certificate of MSME issued by competent Authorities the bids received will be summarily rejected.

The successful bidder will be required to establish Performance Bank Guarantee (**PBG**) for **10%of the Contract Value** within 7 working days from the date of issuance of Letter of Award (LOA). The PBG should be valid and enforceable/en-cashable up to 180 days from its date of issuance. The PBG should be as per the prescribed format (**ANNEXURE-I**). In case the highest bidder fails to submit the PBG, STC reserves the right to forfeit the EMD.

E) GENERAL TERMS & CONDITIONS:

- i) The Red Sanders are in Logs, Chips, Butends and Saw Dust form and Bidder shall have to complete the operations within the time period mentioned in the LOA or as per written instructions given by STC from time to time. STC shall issue clear instructions after nomination and berthing of vessel at designated port and the Bidder will be required to complete the operations on immediate basis. The Agency will co-ordinate with STC.
- ii) EMD of the unsuccessful Bidder(s) will be refunded within 15working days without interest after finalization of the tender.
- iii) Bidder shall keep STC fully indemnified against any claims, losses/damages, liabilities, proceedings etc., from any third party or otherwise arising out of / or in connection with this tender of transportation of Red Sanders.
- iv) STC reserves the right to accept or reject any or all the bids any time at its own discretion without assigning any reasons thereof.
- v) STC may terminate the contract before the expiry of agreed period in case the performance of the bidder is not satisfactory, in which case STC's opinion shall be final and binding. The termination shall be effective immediately from the date of issue of such notice in writing.
- vi) Bidder shall sign the format of Contract as per Annexure–IV as token of acceptance of the terms & conditions stated therein and enclose the same along-with other tender documents to be submitted in the envelope for Techno-commercial Bid.

F) **SUBMISSION OF BIDS:**

The bidders may download the tender document from our website www.stclimited.co.in or www.eprocure.gov.in.

Before submission of the bid, the Bidders are requested to be fully conversant with the Tender Evaluation Criteria "specification, nature of work, the site conditions and general conditions of contract etc., so that, no ambiguity arises at a later date in this respect. Only such individuals, firms, companies need to submit bids who meet the Tender evaluation criteria as laid down in the bid documents and who can submit satisfactory evidence in that regard.

- i) The Corporation reserves the right to revise, amend or cancel the bid documents prior to the date notified for closing to the bids & also the right to postpone the date for presentation and opening of bid without assigning any reason.
- ii) The terminated/debarred/ Black listed bidders from any Govt./Semi Govt./ PSUs/. are not allowed to participate in the bid (Annexure-II). If the Bidder deliberately furnishes wrong information in his bid, the bid would be liable to be rejected out rightly at any stage and the security deposit and/or EMD shall be forfeited and/or may be debarred for business for 2 years.
- iii) Bid documents are not transferable. JV (Joint Ventures) firms are not allowed to participate in the bid. Not more than one bid for the work shall be submitted by one individual contractor or one firm of contractor or company.
- iv) The Corporation shall not be liable for expenses incurred by the Bidder in the preparation of the bid whether the bid is accepted or not. Bids containing any alterations/cuttings/additions/marks of eraser etc even if accompanied by signature shall be liable to be rejected on such grounds.
- v) Bids submitted by courier/post / manual submission to be rejected. Only electronic submission (online) is accepted. Part Bid submissions shall be rejected.
- vi) Price to be quoted in BOQ format in Rs/MTs basis for the quantity to be Exported from Cochin Port.
- vii) Technically qualified bidder quoting the lowest price on Rs/MTS basis will be considered as L-1 Bidder. Successful L-1 (First Lowest) bidder shall be decided on the basis of price quoted in the price bid BOQ section as dictated therein (Annexure-III-B).

The bid is to be furnished in two parts i.e. PART-I (Techno-commercial bid) & PART-II (Price Bid-BOQ format); All the bid documents digitally signed and accompanied by documents in support of tender evaluation criteria / bid enquiry, along with scanned copy of financial instrument (EMD) should be uploaded to the https://eprocure.gov.in/eprocure/app. Price bid

section (Part II) has also to be uploaded in BOQ format on e-mode only (online). The Bill of Quantity (BoQ) must be uploaded after entering the rate in the BoQ for the scope of work.

- a) Bidder shall enter the name of the firm on BoQ only.
- b) Bidders are requested not to edit or change any item or quantity.
- c) Rates in Rs/MTS are to be filled only on BoQ (in .xls format) sheet only.

Note: The filled Price Bid (BoQ) sheet should not be scanned alongwith the Technical Bid documents and such bid will be summarily rejected. No other document has to be attached with Price bid.

The bidder whose Part-I (Techno- Commercial bid) bids have been found acceptable, shall be intimated via e-procurement channel. The price bid of these technically qualified bidders shall be opened on the scheduled due date and time on line. Intimation regarding date and time of opening of price bid shall be intimated through e-procurement portal to the technically qualified bidders.

STC reserves the right to accept or reject any bid, and/or to annul the bidding process and reject all bids, at any time prior to award the contract, without thereby incurring any liability from the affected bidder or bidders nor shall STC have any obligations to inform the affected bidder or bidders of the grounds for STC's action

H) AWARD OF BID:

The bidder, whose bid is accepted by STC, shall be issued Letter of Award (LOA) prior to expiry of bid validity. Bidder shall confirm acceptance within Five (5) days of issuance of LOA by returning signed copy of LOA.

In case the L-1 Bidder fails to submit the PBG/acceptance of LOA within specified period then offer shall be given to L-2 Bidder (Bidder making second lowest offer) to match and confirm L-1's price and if L-2 also fails to submit PBG/accept LOA or reject the offers, then the offer shall be given to L-3 Bidder (Bidder making third lowest offer) at L-1 Bidder's price. This option, however, shall be restricted only up to the L-3 Bidder.

On failing to submit the PBG by successful bidder, the EMD amount will be for fitted.

STC reserves right to allocate any/all lots as mentioned in the table under point no C, to selected Bidder for undertaking the Exports on seeking approval of Directorate of Revenue Intelligence (DRI), Govt. of India.

I) VALIDITY OF BID:

- i. The bidder agrees to and shall hold his bid valid for at least Six (6) months from the date of submission of bids.
- ii. However, the bidder agrees to extend the bid for a further period of (3) months on the existing terms and condition in case the same is desired by STC. The validity of the bids and its security may be extended for a further period on mutual consent.

J) <u>DISCLAIMER</u>:

STC may at its absolute discretion, shortlist, accept, disqualify, elect to abandon, reject any part or whole of the process without giving prior notice to the prospective party. K) JURISIDICTION:

The applicants hereto agree that the Courts and Tribunals at Chennai shall have exclusive jurisdiction to settle any or all disputes which may arise out of or in connection with this Tender. All disputes arising out of this Tender shall be decided in accordance with the laws of India.

L) **INDEMNITY**:

The Bidder shall keep STC indemnified at all times against any claims/ liabilities/ proceedings etc., from any third party or otherwise arising out/ or in connection with this Tender.

M) FORCE MAJEURE:

- i) During continuance of the Contract, STC shall not be held liable or responsible for any loss, claims or demand of any nature whatsoever, and shall not be deemed in breach of the contract because of any delay or failure in observing or performing any of the conditions or provisions in whole or part thereof, if such delay or failure is caused by or arises out of any circumstances whatsoever beyond Agency's control including (but without limiting the generality of the foregoing) declared or undeclared war, hostility, civil commotion, quarantine, sabotage ,blockade, revolution, police action, riots or disorders, embargoes or trade restrictions of any sort, Government or quasi-Government action, acts of God, fire, flood, earthquakes, storms, tides or tidal waves, explosion, accident, radiation, strike, lockouts, or other disputes or epidemic.
- ii) If by reason of any cause beyond the control of Agency there is any curtail mentor suspension of services, then STC shall be excused from the obligations to that extent and STC shall not be bound to arrange delivery/ services by way of hiring or otherwise from other sources.
- iii) If the operation of such conditions continues to exceed three months, either party shall have the right to refuse further performance of the agreement in which case neither party shall have the right to raise any claims/damages.
- iv) The party which is unable to fulfill its engagement shall immediately inform the other party of the existence and of the termination of the circumstances preventing the performance of their obligation.

N) ARBITRATION:

Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach thereof shall be settled by arbitration through the Indian Council of Arbitration, New Delhi, India in accordance with the Arbitration and Conciliation Act 1996 and the award made in pursuance thereof shall be binding on the parties. The venue of arbitration will be at Chennai, India.

Any such demand made on the Bank by STC shall be final

and conclusive and binding on us as regards the amount due and payable by the Bank under this Guarantee. However, our liability under this Guarantee shall be restricted to an amount not exceeding

We also undertake to pay to STC any money so demanded not withstanding any dispute or disputes raised by applicant or any other party in any proceedings pending before any Court of Tribunal, our liability under this presents being absolute and unequivocal. The payment made by us under this Guarantee shall be valid discharge of our liability for payment therein and the applicant shall have no claim against us for making such payment.
