E-tender is invited from the prospective bidders by The State Trading Corporation of India Limited, a Govt. of India Enterprise under the administrative control of the Ministry of Commerce & Industry, having registered office at Jawahar Vyapar Bhawan, New Delhi for disposal of 3 (three) nos. of used Cars on "As is Where is with no complaint basis".

The successful bidder upon awarding of tender will be required to lift the Car after completion of registration formalities/receipt of submission of documents at registration office. However, full payment towards the purchase of car will be required to make within 3 (three) days after award of tender, failing which, the EMD shall be forfeited.

Instructions for filling the e-bid

- **1.** Bids are invited via e-bid process for for disposal of 3 (three) nos. of used Cars on "As is Where is with no complaint basis"
- 2. Bids have to be uploaded online only via https://eprocure.gov.in/eprocure/app (the e-procurement portal of NIC). No bids shall be accepted in hard copy or any other form.
- 3. For submission of e bids, bidders are required to get themselves registered with NIC's central Public Procurement (CPP) portal (https//eprocure.gov.in/eprocure) using class-II/Class –III digital signature certificate. All the details mentioned during registration / enrolment process should be correct and true. Bidders have to abide by all the terms and conditions mentioned during registration process.
- **4.** The details of financial instrument (Tender fee, EMD) (exemption certificate from MSME) need to be uploaded during the e-bid submission and it should tally with the amount received as requirement, otherwise, the bid is liable to get rejected.
- 5. Bidders are advised in their own interest to upload the online bids well before the bid document submission Closing date and time (as per server system clock of CPP). STC shall not be responsible for any delay or the difficulties encountered by the bidder during submission of bids at the eleventh hour on account of any technical or other issues.

- 7. Bidders may regularly visit STC website for any information / clarification / addendum / corrigendum etc. related to this bid, processing of bids received, award of job, pre bid meet decisions etc. STC shall not be liable to send any information individually or publish a public notice for any further information regarding this bid in newspapers.
- 8. Portal for Online Submission is https://eprocure.gov.in/eprocure/app
- **9.** STC may ask the bidders to submit any or all the documents in original or any additional information as part of their online bid anytime during the bid process.
- **10.** If there is a discrepancy between words and figures, the amount in words shall prevail. However, where the amount expressed in words does not represent arithmetically correct total, the amount in figures shall prevail.
- **11.**Bidder has to satisfy STC for ensuring sufficiency of documents necessary for Tender evaluation at his cost if so desired by STC
- 12. The bid document available on e- procurement portal shall be taken as final. STC reserves its right to ask for more document as "Clarification/supporting" only for verification of the uploaded documents. Decision of STC will be final and binding in this regard

TERMS AND CONDITIONS:

- a) The offer should be accompanied with proof of address viz. Aadhaar Card/Voter ID card /Ration card /Passport or any other authenticated document of the bidder alongwith his/her photograph.
- b) The bidder shall sign and stamp each page of the Tender document and all other enclosures appended to it as a token of having read and understood the terms and conditions contained therein and submit the same along with the Bid.
- c) Bid document, if not complete, in any aspect, shall be rejected.

1) Obligation to Rules:

It is obligatory on the part of the Agency/Individual to abide by all the relevant Central, State & Local statutory laws and rules and STC will not be responsible for any dispute arising out of non- compliance of any of such laws and regulations.

2) Earnest Money Deposit (EMD)

- 1. An interest free EMD of ₹ 25000/- (Rs Twenty five thousand only) is required to be furnished online in STC's bank account. This EMD shall be returned to the unsuccessful bidder after satisfactory completion of the job.
- 2. No interest upon return of EMD shall be paid by STC irrespective of the date of return.

3) Rates and Payment:

- **a.** The price quoted may be mentioned both in words and figures and should be valid for a minimum period of 60(Sixty) days from the date of closure of tender. Only quoted Rates shall be considered
- **b.** Taxes / GST as applicable will be inclusive in the quotesd price. Any expenditure involved in transferring the ownership etc. and any applicable rates & taxes payable to concerned authority i.e. RTO/DTO as applicable of the vehicle will be borne by the party only.
- **c.** Full payment towards the purchase of car will be required to make within 3 (three) days after award of Tender, failing which, EMD shall be forfeited.

4) Other Terms and Conditions:

- a. Inspection of vehicle is allowed between 11:00 am to 4:00 pm on working days from 19/01/2021 to 17/02/2021 at STC Office, JawaharVyaparbhawan, Tolstoy Marg, New Delhi-110001.
- b. On purchase of car from STC the successful bidder will have to transfer it in his/her name immediately, but not more than 1 (one) month from the date of purchase and will have to submit the proof thereof to STC.
- **c.** Successful bidder/tenderer will be required to lift the Car within Ten working days after making full payment in STC's account failing which EMD shall be forfeited. In this period bidder has to complete the formalities of RTO for transfer of vehicle and receipt of document submission at RTO will be submitted at STC Office, thereafter delivery of Car will be handed over.
- **d.** The successful tenderer should not use the SIGN of "G" or "Government of India" after the sale of the above vehicle and remove the stickers before taking delivery of the vehicle.
- **e.** The agency shall without any protest or demur, shall always keep STC fully indemnified and shall hold STC harmless against any accident, claims, liability, proceedings etc. by any party including but not limited to damages, compensation, penalties, taxes or other cost and expenses etc. of whatsoever nature arising out of or in relation to any act or omission/ negligence /mistake/misconduct/breach or default or non-fulfillment of the terms and conditions of the Tender Documents and agreement. The agency is bound to take all such necessary precautions for smooth execution of work/transfer of car.
- **f.** All associated activities required for obtaining necessary clearance, permissions, approvals, all licenses from the local bodies, etc required for execution of this work/transfer of car shall be the responsibility of the agency and cost of which shall be borne by the party.

- **g.** STC reserve the right to reject any or all tenders without assigning any reason. The decision of STC in this regard shall be final.
- **h.** The rates of the successful bidder will be valid for 60 days from the date of issue of letter ofacceptance.
- i. Any quotation received by Email/Fax/Courier/Speed Post etc. shall be rejected.
- j. The tender is subject to policy of STC's Management issued from time to time.
- **k.** STC has the discretion to ask for additional information from the bidder.
- **I.** All the tender documents are to be signed as a token of acceptance and signed copy of tender document is to be submitted along with bid document.
- m. Any corrigendum/amendments to tender document will be issued on STC's website.
- 5. **Award of Contract:** STC shall award the contract to the successful bidder with highest quote (H1) separately for each Car. In exceptional circumstances, in case the H1 bidder fails to commence the work at site as per the tender terms, STC will reserve the right to award the work to H2 bidder provided H2 bidder matches to quote of H1 and the EMD/SD of H1 bidder shall stand forfeited. Similarly, if H2 bidder fails to match H1 bid then STC will exercise the option to ask H3 bidder to match H1 bid.

6) SUBMISSSION OF TECHNICAL BID:

The bidder(s) shall submit their online offer along with the following documents:

- a. Signed and stamped Tender documents.

Note: Incomplete offer shall be rejected. Price Bid of the technically qualified bidder will be opened only.



- 4. Leaving an un-filled entry in the Price Bid/ BOQ against any column shall mean as 'zero' cost and the Bid shall be evaluated accordingly.
