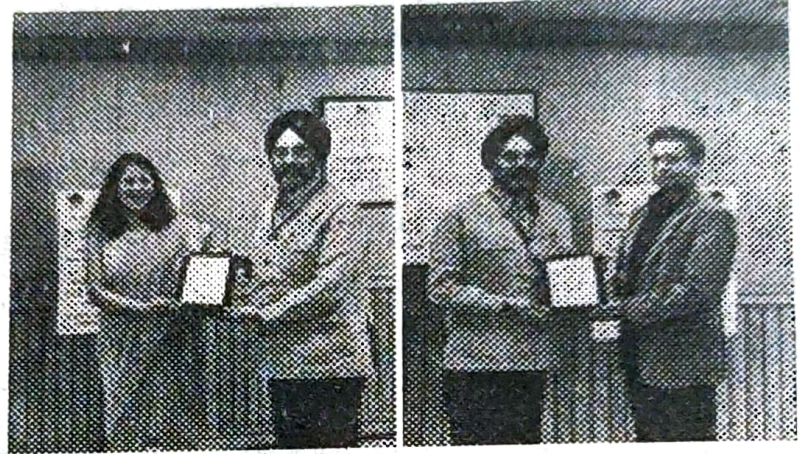


VIGILANCE AWARENESS CAMPAIGN 2024
