**SUMMARY OF PROCEEDINGS OF THE 68TH ANNUAL GENERAL

The 68th Annual General Meeting of the State Trading Corporation of India Limited was held on Friday, September 27, 2024 at 03:30 P.M. through Video Conference.

Members Attendance

50 shareholders including the representative of the Government of India attended the meeting through Video Conference.

Documents available for inspection

Statutory registers and records as per the Companies Act, 2013 were made available for inspection by Shareholders.

Chairman

Shri Hardeep Singh, Chairman and Managing Director chaired the meeting.

Shri Kapil Kumar Gupta, Director (Finance), Shri Satish Kumar Chawla, Independent Director & Chairman of the Audit Committee, Shri Manjeet Kumar Razdan, Independent Director & Chairman of the Stakeholder Relationship Committee, Dr. Rohini Sanjay Kachole, Independent Director & Chairman of the CSR and Nomination & Remuneration Committee, Shri Divakar Shetty Kaup, Independent Director and Shri B. S. Rao, Chief Financial Officer were also present during the Meeting.

Upon confirmation by the Company Secretary that the quorum was present, the Chairman called the meeting to order and the proceedings of the meeting commenced.

The Chairman of the meeting welcomed the shareholders and delivered his speech. With the consent of all the Members present, the notice of the AGM and the Directors Report were taken as "read".

The Company Secretary informed the Members that as per Section 108 of the Companies Act, 2013 read with Rules 20 of the Companies (Management and Administration) Rules 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation 2015, the Company had provided e-voting facility to its members to exercise their right to vote by electronic means from September 24, 2024 (09.00 A.M) to September 26, 2024 (05.00 P.M). The facility of e-voting was made available for such members at the AGM, who could not exercise their vote through remote e-voting process.
