No application of extension of time shall be considered by STC unless it is made by the contractor before scheduled date of completion of work.
- 6. Payment shall be released only after satisfactory completion of job as per **Schedule of Quantity.** Any damage while carrying out repair/replacement work will be on the party's account and no cost will be borne by STC.
- 7. STC may at its discretion, change or alter any specifications or design during the course of execution of work.
- 8. Payment to the contractor shall be released by STC on the basis of work done and amount certified by the concerned Manager. The contractor shall submit the bill in duplicate, giving complete description of the item of work done strictly as per **Schedule of Quantity.**
- 9. Income Tax and Surcharge thereon, WCT, Service Tax & GST etc. will be deducted from the running account bills/final bill as per prevailing rates.
- 10. The contractor shall abide by all municipal bye-laws and safety regulations during execution of work.
- 11. In case of any dispute, decision of Branch Manager, STC will be binding on both the parties.

- 12. Since the payment to the party will be remitted through RTGS/EFT, as such, complete details like Account Number, Name & address of the Bank & Branch, IFS Code with Name & complete address of the firm should also be mentioned in the quotation.
