1) EARNEST MONEY AND TENDER FEE:-

The Bidder shall deposit tender fee of Rs. 525=00 and Earnest Money of amount Rs. 3500/- in the form of crossed bank draft/ Bankers cheque payable to the State Trading Corporation of India Ltd payable at New Delhi.

Any tender, not accompanied with EMD and tender fee are liable for rejection.

In case of unsuccessful bidder, the earnest money will be refunded to them.

Request for adjustment/appropriation of earnest money/deposits if any already lying with the Corporation in connection with some other tender/orders/works shall not be entertained.

No interest shall be payable on earnest money deposits.

- 2) The firm must be registered with Vat and service tax departments and must enclose a copy of registration letter/certificates. The firm must have experience of repair/service of window/split Acs and should be enclosed with proper proof.
- The firm shall use genuine/OEM parts for repair and maintenance. The old parts which are replaced shall be deposited with STC.If the firm uses non-standard parts (genuine) a penalty of double the cost of that part will be imposed.
- 4) STC reserve the right to terminate the contract at any point / during the tenure of contract, if the services are not found satisfactory or if the contractor dishonors the contract. The decision of the STC in this regard shall be final and binding upon the contractor.
- 5) Any financial loss caused due to damage of any part of the ACs of the STC would be deducted from the EMD/performance security/bills.
- 6) Complain calls should be attended promptly and within a reasonable time on all days, including Sundays, Saturdays and holidays. In case the complaints of maintenance/repair of the ACs are not attended within 24 hours, penalty of Rs. 200/-(Per day) will be made and if the AC is out of order for more than 15 days in one season then penalty of Rs. 5000/-(Per day) will be made.
- 7) No Ac or any part shall be taken out by the mechanic to the workshop. The work is to done at site. However, the work which can't be done at

- site would be allowed to be done outside with written permission from STC and no extra charges will be paid for this work.
- 8) Payment of the firm shall be done once in a month on submission of bill duly supported by user certificate to the effect that machine has been serviced and working in good condition.
- 9) Performance security to the tune of 5% of the contract value shall be submitted by the successful contractor in the form of DD/banker cheque in favour of *The State Trading Corporation of India Ltd. payable at New Delhi*, along with acceptance of the contract. The performance security deposit will be forfeited if any deviation by the contractor is found from the instruction given by the STC.After expiring of the contract; the same will be returned after deduction of dues, if any, without any interest.
- The firm shall have to attends all complains on information/direction received from the STC. The services shall be provided on regular basis during the office hours also in case of emergency beyond office hours or holidays.
- 11) If the work of the contractor is found unsatisfactory, the job may be entrusted to other firm at the risk expenses of the defaulting contractor.
- 12) No increase in amount shall be considered at all during the full period of AMC.No other charges will be payable like transportation, fare, etc. for providing the services.
- The rates quoted by the quotationer should be inclusive of all taxes viz VAT, WCT (except service tax), cartage, labour, material etc and there should be no ambiguity whatsoever. The rates shall be firm and no revision of the rates on any account whatsoever shall be considered during the contract. Service tax shall be reimbursed as per prevailing rules.
- 14) The quotationer should quote the rates for the work as mentioned in the bill of quantity.
- 15) STC reserve the right to accept or reject all the quotations without assigning any reason thereof.
- 16) The quotationers must inspect the STC premises/site, before quoting the rates.
- 17) The work shall be carried out as per the direction of the Engineer-incharge.
- 18) STC may its discretion, change or alter any specification or design during the course of execution of work.
- 19) Payment to the contractor shall be released by STC on the basis of work and the amount certified by the Engineer-In-Charge. The contractor shall submit the bills in duplicate, giving complete description of the item of the work done strictly as per the bill of the quantity.
- 20) Taxes will be deducted from the running account bills /final bill as per the prevailing rates.
- 21) The contactor shall abide by municipal bye-laws, safety regulation and labour laws during the execution of the work.

- 22) In case of any dispute, decision of Engineer-In-Charge, STC will be binding on both the parties.
- 23) Since the payment to the party will be remitted through RTGS/EFT, as such, complete detail like Account no., name and address of Bank and Branch, IFS code with the name and complete address of the firm shall be required at the time of payment.
- 24) The warranty period of the work shall be six months or OEM warranty which is later.
- 25) The contractor shall start the work which is stipulated period as mentioned in the award letter failing which no tender /quotation shall be issued in future works.
- The period of the annual contract shall be for one year from the date of award of the contact. The contract may be extended for further period of one year by STC on the basis of satisfactory performance by the firm.
- 27) The maintenance/servicing include oiling, cleaning, greasing, gas charging, repair of compressors/motors, electrical parts, air filters, wiring, replacement of old motor by new one etc.
- 28) The Indemnity Clause

The Contractor shall at all times indemnify and keep STC indemnified against any claims / liability/ proceedings etc. in respect of any damages or compensation payable in consequences of any accident or injury sustained or suffered by its employees/workmen or agents or by any other third party resulting from or by any action, omission or operation conducted by or on behalf of the Contractor.

The Contractor shall at all times, indemnify and keep indemnified STC against any and all claims / liability/ proceedings etc. of the Employees, Workman, agent(s), employed engaged or otherwise working for the Contractor, in respect of wages, salaries, remuneration, compensation or the like.

All claims regarding indemnity shall survive the termination or expiry of the Contract and shall be recoverable from Security Deposit in addition to any other means.

- 29) VALIDITY OF TENDER:-
