**DETAILED TERMS AND CONDITIONS**

1. The State Trading Corporation of India Ltd., a Government of India Enterprise invites sealed bids from the interested persons to run a Canteen / Snack Bar in their seven storied premises at Nandini Layout, at the above address for catering to around 200 – 300 persons in a day for a period of one year, extendable at mutual discussions and consent.
2. The Canteen / Snack Bar is to be located in the Terrace Floor, where covered roofing, tables, chairs, for seating 20 people, and facility for taking snacks standing for 50 people is available. Further, cooking platform, wash basin and washing facility are also provided. Electrical lights, ceiling fans, and Heat extractors are also provided. Further, Power points are also available for electrical heater. The power and water for washing purposes will be provided by STC free of cost.
3. The premise has people working in round the clock. The Canteen / Snack Bar have to cater to people working in all shifts.
4. The Canteen / Snack Bar have to serve strictly the vegetarian food only. Preparation of food on the spot is to be limited only to Tea. Coffee, Juices, cool drinks and any other light items. Other pre-prepared food items can also be served after heating.
5. The required licenses from the Statutory Authorities like BBMP etc., for running the Canteen/Snack Bar are to be arranged by the bidders including fee payable if any to the Statutory Authorities. STC will not arrange for the same.
6. Any additional tables & chairs required, gas stove, gas cylinders, drinking water etc., are to be arranged by the bidder only.
7. The bidder has to submit a list of food items he proposes to be serve with their selling price along with the bid and the actual selling price of the successful bidder has to be implemented only after approval by the STC of India Ltd.,
8. The bidders have to submit their bids in their Letter Heads along with signed copy of the detailed terms and conditions for having accepting the same.
9. Further, we (M/s ..... ) agree to pay an amount of Rs...../-per month as Canteen Running Fee to the STC of India Ltd., (Total amount for TWELVE months be adjusted out of the EMD paid to the extent possible and balance will be paid in cash separately).
10. The bid should accompany an EMD of Rs.5, 000/- by DD in favour of STC of India Ltd., Bangalore.
11. The successful bidder will have to enter into an Agreement with STC of India Ltd., for running the canteen.
12. The EMD of unsuccessful bidders will be refunded.
