NOTICE FOR INVITING TENDER FROM EMPANELLED SUPPLIERS FOR SUPPLY OF ALMOND (BADAM SEEDS) & CARDAMOM AT BAGALKOT FOR THE MONTH OF JUNE 2017.

In order to appoint the backup supplier for supply of 500 KGs (\pm 25%) of Almond & 100 KGs (\pm 25%) of Cardamom to M/s Dempo Dairy Industries Limited (DDIL), Bagalkot., STC is inviting quotations through Central Procurement Portal (CPP), inclusive of VAT/CST wherever applicable (as per the ANNEXURE – I), with validity of offer for 90 days from the date of offer or till the time actual delivery is made whichever is later.

The tender would be in two bid system i.e. Technical Bid and Price Bid/Financial Bid. Parties who qualify the Technical Bid will only be eligible for Price Bid. Price Bid of those suppliers who qualify Technical bid will only be opened. Price Bid of the suppliers who do not satisfy any/all terms and conditions specifically so mentioned in the technical bid shall be summarily rejected. The contents of the Technical Bid and Price Bid are listed below:

Contents of Technical Bid:

- a. Signed and stamped copy of Annexure III (in company's letter head)
- b. Proof of EMD and Processing Fee payment (receipt challan etc.)

Contents of Financial Bid:

a. Price Bid in the format given in Annexure I

TERMS & CONDITIONS:

- 1. The parties who offer the lowest quotations shall be appointed as backup supplier for above. The parties submitting the bids should agree for supply of entire quantity of 500 KGs (\pm 25%) of Almond & 100 KGs (\pm 25%) at M/s DDIL, Asangi.
- 2. Selected parties should agree for all the terms and conditions of M/s Dempo Dairy Industries Ltd tender no DDIL/Pur/2017-18/ 252 dt 10.05.2017, including initial EMD of Rs.45000 and Processing Fees of Rs.550/-.
- 3. Upon successful awarding of the tender the back-up supplier must furnish Rs.75,000/- towards Security Deposit to M/s DDIL through STC.
- 4. Undertaking from all the participants that the terms and conditions of M/s DDIL are accepted by them and the same shall be complied with.
- 5. All terms and conditions are to be accepted by the back-up supplier.
- 6. The back-up supplier must also furnish Additional Security Deposit of Rs.75,000/-exclusively for STC in addition to the security deposit submitted to M/s DDIL.
- 7. Quality test certificate from repute laboratory shall be furnished for each consignment.

8. The bidder has to give an undertaking that he shall not directly participate in the above referred tender directly, while applying through STC.

OTHERS TERMS & CONDITIONS:

- 1. Upon awarding of the tender to STC the back-up supplier will have to execute contract on a Rs.200 Stamp paper with STC within the stipulated time.
- 2. Payment for the consignment would be made after completion of delivery and on conformity of the quality of the said consignment, and on receipt of the same from M/s Dempo Dairy which is likely to be within 15 days time.
- 3. STC has got the sole right to wholly or partly cancel the order without assigning any reason
- 4. Signed copy of the tender document may please be uploaded as token of acceptance of the said tender. Quotes received other than CPP portal shall not be accepted.

SPECIFICATION OF ALMOND (BADAM) SEEDS

- 1. First quality, preference will given for American variety, Dry form and moisture shall not be more than 5% (natural brown color preferred).
- 2. Seeds shall be of uniform size without touching.
- 3. Seeds shall be free from abnormal taste.
- 4. Seeds shall be packed in 50 Kg plastic liner covered with HDPE bag with outer gunny bag or seeds shall be suitably packed to protect the quality of seeds.
- 5. Batch no.& date of manufacture shall be mentioned on every packet.

SPECIFICATION OF CARDAMOM (ELAICHI) SEEDS

The cardamom seeds shall conform to PFA standards with the following requirements.

 Shall have characteristics flavour free from foreign odour, mustiness or rancidity. It shall be free from mould, living and dead insects, fragments and rodent contamination. Shall be free from added colouring matter or any other harmful substances.
