Terms and conditions for providing car hire services on monthly / day to day

- 1. The period of contract will be one year from the date of awarding the contract subject to renewal for further one year on existing terms and conditions at the discreation of STC.
- 2. The cars to be provided should not be more than three years old and should be well maintained.
- 3. The cars should be registered as tourist taxi and RTO and appropriate govt. authorities.
- 4. The driver should be well mannered, experienced, well uniformed and should carry a mobile phone.
- 5. The driver should possess a valid driving license.
- 6. AThe opening and closing Kms./hrs. would be reckoned from STC office/apartment.
- 7. Expenditure/charges towards drivers salary, fuel charges, repairing and maintenance, RTO (fine) charges if any shall be borne by the
- 8. Charges towards toll and parking would be paid at actual.
- 9. No request for enhancing the rate due to hike in fuel prices/ insurance premier etc. would be entertained during the tenure of the
- 10. In case of car hiring on monthly basis, a fixed payment for 1500 Kms. and 260 hrs. per month would be paid. Beyond 1500 Kms. and 260 hrs per month the rate for per km and additional hrs may be quoted
- 11. Applicable service tax would be payable to the agency
- 12. Applicable Tax would be deducted at source
- 13. STC will not be responsible or liable in case of any dispute arising between the agency and the drivers employed by the agency and no relationship of employer and employee shall come into existance between STC and agency or driver for which all responsibilities shall vest with the agency alone.

14.STC reserves the right to terminate this arrangement without assigning any reasons thereof, by serving a notice of one month to this effect, and on the refusal of the agency to accept the notice of termination of the arrangement or passive avoidance to do so, the said notice shall be sent by Regd. Post on the address of the agency recorded with STC where it shall be deemed to have been served on the agency.

15. In case of any dispute arising out/relating to interpretation of terms and conditions or functioning of the agency vis a vis STC, STC shall be the sole authority to decide the dispute.
