SCOPE OF WORK

The Government of Puducherry every year distributes 9 Nos. of Pongal Gift items at free of cost to all the family ration cardholder in Puducherry, Karaikal, Mahe and Yanam regions on the occasion of Pongal Festival to celebrate festival. The items are Raw Rice(1 Kg.), Sugar(1 Kg.), Toor dhall(1/2 Kg.), Orid dhall(1/2 Kg.), Moong Dhall(1/2 Kg.), Jaggery(1/2 Kg.), Cashew Nut(25 gms), Raisin(25 gms) and Cardamom(10 gms) to each family cardholder through M/s. PAPSCO in Puducherry, Karaikal & Mahe regions and through M/s. Yanam Cooperative Stores Limited, Yanam. The procurement and distributions are undertaken by PAPSCO & YCSL at their respective regions. - d) Supplied items may be subjected to quality analysis and PAPSCO at its discretion shall send samples of any consignment to the accredited (or) any other laboratory for analysis. In such cases, the result of accredited/lab is final.
