NOTICE FOR INVITING LIMITED TENDER FROM EMPANELLED SUPPLIERS FOR SUPPLY OF RICE TO M/s. Puducherry Agro Products, Food & Civil Supplies Corporation Ltd., (PAPSCO) for Puducherry, Karaikkal & Mahe Regions and Wheat for Mahe Region for Public Distribution Scheme.

M/s PAPSCO, Puducherry, has invited a tender bearing No.10-1/Rice & Wheat/e-Tender/PAPSCO/2017-18 dated 28.02.2018 for supply of **37560 MTs Rice** being 6 months supply with quantity mentioned against each for Puducherry, Karaikkal & Mahe Regions and 240 MTs Wheat for Mahe Region for Public Distribution Scheme. The quantity to be offered for 6 (six) months for the period from February 2018 to July 2018 is about 37560 MTs Rice (Puducherry 30000 MTs, Karaikal 6840 MTs and Mahe 720 MTs) & 240 MTs Wheat for Mahe Region.

You are requested to quote the rate of Trade Margin (in percentage (%) as per Annexure-I payable nett to STC for the purpose of selecting the Back-up Supplier for supply of above items to M/s PAPSCO. **The Percentage of Trade Margin quoted shall not be less than 1%. The party who quotes highest trade margin in % terms will be considered.** In the event of same Trade Margin Offered by two or more Suppliers the Quantity would be apportioned proportionately to them on mutual consent. In case if the Parties are not agreeing for bifurcation of the Quantity, STC shall have the final decision on selection of the Supplier.

The shortlisted back up supplier(s) shall submit an undertaking that in the subject tender they shall be exclusively participating only through STC and will not directly or through any other company participate in the said tender. If the same is found so, at later date, the said supplier will be debarred for further tender participation through STC intimation to all State and Central Government Departments.

It is to be clearly agreed in your offer that you shall take full responsibility for the quality and quantity variations and claim if any, and agree to settle the same, including replacement, from your side, indemnifying The State Trading Corporation of India Ltd from any such claim.

The successful supplier shall quote the rate per kg either for all 3 regions viz., Puducherry, Karaikal and Mahe regions (or) for any selected region of Puducherry/Karaikal/Mahe for supply of 20 kg (net weight) rice in Polypropylene (PP) bags (PP bags of the supplier with PAPSCO Logo including of cost of PP bag for Puducherry & Karaikal regions and 15 kg (net weight) Rice & 5 kg (net weight) Wheat for Mahe region. The successful supplier shall quote the rate maximum of 2 lots @ 1000 MTs each lot per month (maximum 12000 MTs) for Puducherry Region and 2 lots @ 540 MTs each lot per month for Karaikal Region (maximum 3240 MTs) and full quantity of 720 MTs Rice & 240 MTs Wheat for Mahe in a single lot; if the successful supplier quotes for more than two lots in a month in any region his offer will be rejected/will not be considered.

The Price to be offered by the successful supplier for supply is at Ex-fair price shop that would be mentioned by M/s. PAPSCO while issuing the Permit and the rate is inclusive of packing charges, all duties, GSTIN and any other statutory taxes as applicable with validity of two months from the date of offer or till the time actual delivery is made to M/s PAPSCO whichever is later.

The quantity mentioned above is tentative and subject to vary depending upon receipt of further orders from M/s PAPSCO, Puducherry, for Public Distribution Scheme.

STC shall have the right to wholly or partly cancel the order in the event of any cancellation or order by M/s PAPSCO, in any manner.

Only the empanelled suppliers enrolled with STC are eligible for participating in the above Tender.

The successful supplier has to arrange the above supply to M/s PAPSCO at their nominated godowns directly and the rate offered should be inclusive of transportation (Freight), Transit insurance, Packing charges and admissible GSTIN, for delivery at M/s PAPSCO'S godowns.

The successful supplier has to arrange the above supply by using their own funds and no financial assistance will be given from STC.

The successful supplier shall deposit EMD @ Rs.5,00,000/= @ 1000 MTs per lot for the quantity offered for Puducherry, Rs.3,00,000/= @ 540 MTs per lot for the quantity offered for Karaikal and Mahe Rs.95,000/= (Rs.70,000/= single lot of 120 MTs of Rice and Rs.25000/= single lot of 40 MTs of Wheat) . The successful supplier shall also deposit Security Deposit @ 5% of the total value of the stocks.

In addition to above, the successful supplier shall also deposit "Additional Security Deposit" of 5% payment towards total value of the stocks (exclusively for STC) to be deposited through RTGS or Bank Guarantee to STC and dated cheque for 95% contract value and shall agree to abide all the tender terms and conditions of M/s PAPSCO.

STC shall not accept conditional offer from the bidders.

STC shall add its Trade Margin plus applicable GST and other taxes over and above the price to be offered by the successful Supplier and offer the final price to M/s. PAPSCO while participating in the Tender for above supply.

: 3 :

The successful supplier shall arrange for supply of the material in packed form adhering strictly to the tender specification.

The successful supplier has to raise Invoice on STC on receipt of which STC shall raise the Invoice to M/s. PAPSCO. **Payment to the supplier will be released only on receipt of payment from M/s PAPSCO**

In the event of non supply or failure to supply, the full or part of the agreed quantity by the successful tenderer, STC shall have the sole right to arrange for supply of the balance quantity by other empanelled parties and in the event of any revision in cost is payable, the difference shall be collected from the party in addition to the penalty clause and penal interest and other cost and expenses etc and the party should agree for the same without any protest or demur. A simple notice from STC is sufficient to inform the party that the balance unsupplied quantity would be arranged through the other empanelled suppliers which binding on the party.

The quotation should invariably state that the Tenderer agrees to all the terms and conditions for supply of this tender.

The Successful Tenderer shall indemnify STC from any claim on Quality, Quantity, delay or non-supply etc., and shall agree for replacement of rejected quantity at their own cost.
