Terms and Condition –

1) **EARNEST MONEY AND TENDER FEE:-**

The Bidder shall deposit tender fee of Rs. 525=00 and Earnest Money of amount Rs. 3600/- in the form of crossed bank draft/ Bankers cheque payable to the State Trading Corporation of India Ltd payable at New Delhi.

Any tender, not accompanied with EMD and tender fee are liable for rejection.

In case of unsuccessful bidder, the earnest money will be refunded to them.

Request for adjustment/appropriation of earnest money/deposits if any already lying with the Corporation in connection with some other tender/orders/works shall not be entertained.

No interest shall be payable on earnest money deposits.

2) The firm must be registered with Vat and service tax departments and must enclose a copy of registration letter/certificates. The firm must have experience of piping works and should be enclosed with proper proof.

3) The firm shall use genuine parts for installation work. The old parts which are replaced shall be deposited with STC. If the firm uses non-standard parts (genuine) a penalty of double the cost of that part will be imposed.

4) STC reserves the right to terminate the contract at any point / during the tenure of contract, if the services are not found satisfactory or if the contractor dishonours the contract. The decision of the STC in this regard shall be final and binding upon the contractor.

5) Any financial loss caused due to damage of any part of nearby machineries of the STC would be deducted from the EMD/performance security/bills.

6) The work shall be completed within 30 days and for delay the penalty of Rs.1000/- per day shall be imposed & it can go up to 10 % of the contract value.

7) Payment of the firm shall be done only after completion of work on submission of bill and certification of engineer in charge.

8) **SECURITY DEPOSIT: -**

The 5% S.D. Will be deducted from the bills by STC.

Release of Security Deposit: - The 5 % security amount (S.D.), shall be released only after successful completion of defect liability period of one year. If the contractor firm fails and neglects to observe or perform any of its obligation under the contract it will be lawful for the STC to forfeit, at its absolute discretion, the security deposited to STC and / or STC reserve the right to arrange the work through any other agency at the risk and cost of the contractor.

No interest shall be payable on such deposits.

- 9) If the work of the contractor is found unsatisfactory, the job may be entrusted to other firm at the risk expenses of the defaulting contractor.
- 10) No increase in amount shall be considered at all during the currency of the contract. No other charges will be payable like transportation, fare, etc.
- 11) The rates quoted by the quotationer should be inclusive of all taxes viz VAT, WCT (except service tax), cartage, labour, material etc and there should be no ambiguity whatsoever. The rates shall be firm and no revision of the rates on any account whatsoever shall be considered during the contract. Service tax shall be reimbursed as per prevailing rules.
- 12) The quotationer should quote the rates for the work as mentioned in the bill of quantity.
- 13) STC reserve the right to accept or reject all the quotations without assigning any reason thereof.
- 14) The quotationer must inspect the STC premises/site, before quoting the rates.
- 15) The work shall be carried out as per the direction of the Engineer-in-charge.
- 16) STC may its discretion, change or alters any specification or design during the course of execution of work.
- 17) Payment to the contractor shall be released by STC on the basis of work and the amount certified by the Engineer-In-Charge. The contractor shall submit the bills in duplicate, giving complete description of the item of the work done strictly as per the bill of the quantity.
- 18) Taxes will be deducted from the running account bills /final bill as per the prevailing rates.
- 19) The contactor shall abide by municipal bye-laws, safety regulation and labour laws during the execution of the work.
- 20) In case of any dispute, decision of Engineer-In-Charge, STC will be binding on both the parties.
- 21) Since the payment to the party will be remitted through RTGS/EFT, as such, complete detail like Account no., name and address of Bank and Branch, IFS code with the name and complete address of the firm shall be required at the time of payment.
- 22) The warranty period of the work shall be 12 months or OEM warranty which is later.
- 23) The contractor shall start the work within the stipulated period as mentioned in the award letter failing which no tender /quotation shall be issued in future works.
- 24) The period of the contract shall be 30 days from the date of award of the contact.
- 25) The Indemnity Clause

The Contractor shall at all times indemnify and keep STC indemnified against any claims / liability/ proceedings etc. in respect of any damages or compensation payable in consequences of any accident or injury sustained or suffered by its employees/workmen or agents or by any other third party resulting from or by any action, omission or operation conducted by or on behalf of the Contractor.

The Contractor shall at all times, indemnify and keep indemnified STC against any and all claims / liability/ proceedings etc. of the Employees, Workman, agent(s), employed engaged or otherwise working for the Contractor, in respect of wages, salaries, remuneration, compensation or the like.

All claims regarding indemnity shall survive the termination or expiry of the Contract and shall be recoverable from Security Deposit in addition to any other means.

- 26) VALIDITY OF TENDER:-

The bid shall remain open for 20 days which will reckon from the date of opening of bid. During this period the bidder shall not be allowed to withdraw or amend or impair or derogate his offer and Earnest money deposited shall not be withdrawn within this period.

- 27) All the pages of quotation shall be signed and stamped by the authorized person the firm.
- 28) Scope of work- DGs cooling Water lines (02nos.) are now connected to the water tank placed on the ground floor. These are to be connected to the AC cooling tower. All required material for the work like pipes/values/fledges etc is to be supplied and installed. Hence bidders are requested to visit our site before filling the tender.
