Terms & Conditions:

- 2. Delivery Schedule Immediate delivery, and commissioning of equipment should be clearly specified in the offer.
- 3. Payment Terms I: Clause (g) to read as

"Certificate from the manufacturer to the effect that the goods conform to the manufacturers standards and are new (**Production Month in Year 2018/19**) and free from any latent or patent defects and are strictly as per Specifications mentioned in STC's Order."

- 4. <u>Clause (6): Airport/Port of Shipment</u> to read as "For Imported equipment supply to be made through Rajiv Gandhi International Airport, Hyderabad and to be delivered at A.P. Police Headquarters, Mangalagiri."
- 5. Clause (12)-A-2: date of close of tender may be read as "10.08.2018".
- 6. Clause (12)-B-PRICE BID should include
 - 1. Price to be quoted for each item separately, inclusive of one year comprehensive warranty.
