**Empanelment of Global Manufacturers of UIC 60Kg (880 Grade) Class A Rails of  
25m or 26m lengths for supply to Indian Railways**

**Clause No. 2.1 of EOI may be read as under in place of existing:-**

The tenderer should have the experience of manufacturing of UIC 60kg and/or 60E1 and/or 60E2 and/or Heavier section rails (880 grade and/or R260 grade, as per European Standard EN13674-1:2011, and/or higher grade) for at least last seven years i.e. 2010-11, 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 and 2016-17.

**Clause No. 2.2 of EOI may be read as under in place of existing:-**

The tenderer should have supplied a minimum of 5,00,000 MT UIC 60kg and/or 60E1 and/or 60E2 and/or Heavier section rails (880 grade and/or R260 grade, as per European Standard EN13674-1:2011, and/or higher grade) during five years period comprising 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 (i.e. period from 01.04.2010 to 31.03.2015) to passenger traffic/mixed traffic carrying railway systems in operation. These rails should be in use for more than two years on such railway systems in operation and performance found satisfactory for which a certificate of satisfactory performance issued by respective railway systems should be submitted by the tenderer.

**Clause No. 2.3 of EOI may be read as under in place of existing:-**

A minimum of 1,00,000 MT of Rails including minimum 25,000 MT UIC 60kg and/or 60E1 and/or 60E2 (880 grade and/or R260 grade, as per European Standard EN13674-1:2011, and/or higher grade) per annum should have been supplied by the tenderer to any of the railway systems in operation in each year during the last two years i.e. from 01.04.2015 to 31.03.2017

**Clause No. 2.4 of EOI may be read as under in place of existing:-**

In case manufacturing facility is located outside the purchaser's country, then tenderer should have exported a minimum of 1,00,000 MT of UIC 60kg and/or 60E1 and/or 60E2 and/or Heavier section rails (880 grade and/or R260 grade, as per European Standard EN13674-1:2011, and/or higher grade) to any railway system(s) in operation in last two years, i.e. from 01.04.2015 to 31.03.2017.

Last Date/Time for submission of applications to above EOI has been extended upto **21.12.2017/ 1500 Hours (IST).**

Date/Time of Opening of EOI has been extended upto **21.12.2017/ 1600 Hours (IST).**
