

CORRIGENDUM No. 1 dated 18.09.14

Tender No STC/AC/RICE/IMP/01/2014-15 dated 08.09.2014 for Import of Rice

The following corrigendum is issued to the subject tender:

Tender Closing Time & Date: 15:00 hours Indian Standard Time (IST) on 30th September, 2014

Tender Opening Time & Date: 15:30 hours Indian Standard Time (IST) on 30th September, 2014

Clause (II): PACKING: The rice shall be packed in uniform, new, strong polypropylene bags of international export standard (colour White), with minimum weight of 130 gm containing not less than 50 kgs net per bag, securely DOUBLE machine stitched/ sealed at the mouth.

Clause (III) SPECIFICATIONS:

Rice shall be in sound merchantable condition, sweet, dry, clean, wholesome, of good food value, uniform in colour and size of grain and free from moulds, weevils, obnoxious smell, admixture of unwholesome poisonous substances, Argemone mexicana and Lathyrus sativus(Khesari) in any form, or colouring agents and all impurities except to the extent in the schedule below. It shall also conform to PFA standards.

Clause (IV): DELIVERY PERIOD: 25th October to 25th November, 2014

Clause (IX):

QUANTITY, WEIGHT & QUALITY: Independent reputed international inspection agency nominated by the Buyer at buyer's cost shall inspect cargo at nominated godowns of FCI in Imphal, Manipur (India). In case of rejection by the Independent inspection agency, the supplier shall replace the rejected cargo with fresh stocks conforming to the Contractual quality specification.

Suppliers may also note that the phytosanitary certificate should be issued by the specified Authority of the country of origin. In case the country of origin is other than Myanmar, then two such phytosanitary certificates are required one from the country of origin and the second from the transit country (Myanmar) from where the goods are entering the Indian territory.

Clause (XII) FUMIGATION para no. b to be read as

b. Seller must ensure conformity to quality requirements pertaining to "Grain for consumption from any country should be free from granary weevil (Sitophilus granarius) and fumigated with Methyl Bromide @ 32 /g/cu.m at 21° C and above for 24 hrs under NAP and the treatment to be endorsed on phytosanitary certificate"

Clause (XV)

PERFORMANCE BANK GUARANTEE: In case of **confirmation of business**, successful supplier shall provide performance bank guarantee in EURO equivalent to 3% value of the contract within five working days from the date of finalization of business as per STC's standard format (Annexure-V), failing which STC reserve rights to forfeit/invoke the EMD/Bid Bond. The PBG shall be valid for six month from the date of issue of PBG.

The successful supplier has the option of amending the bid bond submitted against the tender as a performance guarantee bond by incorporating all the wordings appearing as per format Annexure V. In such case the amendment should be confirmed through the issuing bank and their correspondent bank. Failure to submit amendment of bid guarantee as per STC's standard format (Annexure V) of tender shall result in STC invoking the bid bond and forfeiting the EMD/Bid guarantee amount.

Annexure V of Performance Guarantee format: Para No. 2 to be read as

2. It is fully understood that this guarantee is effective for the period (upto six months from the date of issue of PBG) and that we _____Bank undertake not to revoke this guarantee during its currency without the consent in writing of the Buyer.
