INTRODUCTION

Rashtriya Ispat Nigam Ltd. (RINL), Visakhapatnam Steel Plant (VSP) have invited a tender from indigenous suppliers for supply of 98,000 MTs of SMS Dolomite Flux Grade conforming to technical specifications and as per modalities specified in their invitation for Tender No. Pur-20003328/2016 dtd 18/12/2015 along with Corrigendum No. 1 dtd 22/12/2015 and as per Notice of Invitation to Tender along with Annexures No. I to IX of the said tender (https://www.vizagsteel.com/code/tenders/tenderfiles/19130Corrigendum%20SMS%20DOLO_2015%20DOC%20%20.pdf)

Scope of work includes delivery of the entire quantity on FOR Loading point basis inclusive of all taxes, cess, duties and royalty with delivery schedule of 16,000 MTs per month from February 2016 onwards and with deliveries commencing within 7 to 10 days from acceptance of tender. 100% payment will be made by RINL to their supplier on the 60th day from submission of dispatch documents to them. The successful tenderer/supplier would have to submit a 5% Performance Guarantee. The delivery schedule and timely supply is essence of the contract.

STC intends to engage Associates on back up basis for above supplies to RINL as per their terms and conditions. The Back-up Associate will be engaged on the basis of STC's Short Time Tender Notice No. STC/HYD/Dolomite/RINL/2015-16/01 dtd 30/12/2015 seeking Trading Margins (% of FOR Landed Cost) to STC for the said supplies. Closing date for submission of Trading Margin Bid/Quote along with required information and documents is 05/01/2016 at 1200 Hrs.

Thereafter, specific back up Techno-commercial and price offer for STC's participation in RINL Tender will be taken from the selected Associate. 1. Minimum experience of three years of production/supply of the said item with documentary evidence of the same.
2. Should have valid PAN No., TIN No., CST No., Excise, Service Tax registrations, Trade License, and audited annual accounts for the last three Financial Years.
3. Should be preferably with positive net-worth and profit.
4. Should not be debarred/black listed for business with Government agencies.
5. Should have a valid lease agreement granted by a State Government or a lease agreement /LOA with a lease holder / Mines Owner for supply of material.
