ENROLMENT OF ACTUAL USERS OF MAIZE/CORN (NON-GMO) TO BE IMPORTED BY STC UNDER TRQ

Directorate General of Foreign Trade, New Delhi vide its Public Notice No.22/2015-2020 dated 11.07.2016 has issued amendments in the procedure of Tariff Rate Quota Scheme for import of Maize (Corn) -Non GMO. The State Trading Corporation of India Ltd., amongst other STEs has also been made as an eligible entity to apply under available total quota of 5,00,000 Metric Tons of Maize (Corn) on behalf of Applicants/Actual Users.

Actual users, therefore, may expeditiously indicate their immediate import requirement to the undersigned (quantity along with choice of discharge port). For indicating the quantity requirements, the actual user should send the duly filled signed and stamped Annexure I and II, by fax at 011-23701136/011-23701123 or e-mail at akhil@stclimited.co.in / shivam@stclimited.co.in, latest by 1200 Hrs of 21.07.2016. The hard copy of Annexures along with all the application documents, as listed below, must be received by STC Head Office, addressed to Deputy General Manager (Agro-Division), 6th Floor, The State Trading Corporation of India Limited, Jawahar Vyapar Bhawan, 1 Tolstoy Marg, New Delhi-110001 latest by 25.07.2016, by hand delivery or Speed Post/courier. The envelope should be marked as "Application for Import of Maize under TRQ". **Only actual users may express interest, and trade of allotted cargo is prohibited.**

Based on the interest received from the buyers, STC shall float the tender for import of Maize (Non GMO) from international suppliers. The tenders and the shipments periods shall be phased in such a manner so as to enable STC to complete the import process within the stipulated time period.

The Applicants desirous of applying for the quota for import of Maize (Corn) –Non- GMO under TRQ are required to submit the following documents for making application to DGFT for allocation of quota :-

1. Consent letter of the applicant authorizing STC to apply on their behalf indicating the specific quantity for allocation of the quota for import of Maize (Corn)- Non GMO.
2. A copy of registration certificate of being Company registered with the Registrar of Companies.
3. A copy of registration certificate being registered with the sales tax/VAT

4. A copy of the PAN No.
5. A copy of registration certificate from the State Govt. as actual user, if applicable.
6. A copy of license of the Manufacturing unit if the imported corn is to be processed for corn bases products under Actual User condition.
7. A copy of Statement indicating the quantity imported, processed, marketed by the actual user in the last three financial years.
8. Copies of balance sheet/profit & loss account for the last 3 years. In case the Company being registered new, the Bank report is to be submitted.
9. The applicant to submit Self declaration on non-judicial stamp paper of Rs.100/- that applicants who had been allocated quota for import of maize during the preceding years have not defaulted in the matter of compliance actual user condition or not under scrutiny by various statutory authorities including DRI, Customs or Income Tax, etc. If yes, in details of such violation be provided on a separate annexure along with the application.
10. Undertaking on the Company Letterhead declaring plant capacity of the manufacturing/processing unit, as at Annexure I
11. Duly filled signed and stamped Annexure II, indicating the firm demand (Commensurate with the plant capacity), and preferred port of discharge, along with other details.
12. **Indemnification:** The Actual user without any protest or demur, shall always keep the STC fully indemnified and shall hold the STC harmless against any claims, liability, proceedings etc. by any third party including but not limited to damages, demurrage, penalties, taxes or other cost and expenses etc of whatsoever nature arising out of or in relation to any act or omission/ negligence/ mistake/ misconduct/ breach or default or non fulfilment of the terms and conditions of his Agreement with STC.
13. We may call for further information from actual users, subject to Government rules, regulations and guidelines issued from time to time.

Note:

1. The registration with STC does not guarantee the allocation of import quota for import of maize (corn) under TRQ. The final allocation against the indented quantities may be increased or decreased depending upon the overall availability of the sanctioned quota and rules defining allotment thereof.
2. STC reserves the exclusive right to accept or reject either partially or wholly the application filed by the applicant without assigning any reason whatsoever.
3. The final choice of port of discharge shall be on STC's discretion on the basis of demand received by us at various ports out of the options provided in Annexure.
