#### **TERMS AND CONDITIONS**

- 1. The rates to be quoted by the tenderer should be inclusive of all taxes, cartage etc., and there should be no ambiguity whatsoever. The rates shall be firm and no revision of rates on any account whatsoever shall be considered during the contract period.
- 2. The tenderer should quote the rates for the work as mentioned in the Bill of Quantity.
- 3. STC reserves the right to accept or reject all the tenders without assigning any reason thereof.
- 4. The tenderer must inspect the STC premises/site, before quoting the rates.
- 5. The work shall be carried out as per the direction of Engineer-in-Charge. All problems shall be sorted out within 48 hours except major fault like repairing of pumps in which case time may be allowed upto seven (7) days. The contractor shall make arrangement of stand by pump, in case of failure of existing pump/motor.
- 6. Water supply and electricity for the both fountains shall be supplied by STC free of cost
- 7. STC may at its discretion, change or alter any specifications or design during the course of execution of work.
- 8. Payment to the contractor shall be released after satisfactory completion of work and amount certified by the Engineer-in-Charge. The contractor shall submit the bills, giving complete description of the item of work done strictly as per Bill of Quantity.
- 9. WCT, Income Tax and Surcharge thereon will be deducted from the monthly AMC bill.
- 10. The contractor shall abide by all municipal bye-laws and safety regulations during execution of work.
- 11. In case of any dispute, decision of Chief General Manager (P&A), STC will be binding on both the parties.

- 12. The successful bidder shall be required to make an interest free Security Deposit calculated at the rate of 10% of the yearly value of contract. In the form of Demand Draft/Pay order in favour of "STC of India Ltd., New Delhi" before the commencement of the contract. After receipt of necessary security deposit, the Earnest Money of Rs.5,000/- will be refunded to the un-successful bidder. The Security Deposit will be refunded after three months of expiry of the contract and after adjustment of dues, if any, on the recommendation of Engineer Incharge certifying the successful completion of the contract.
- 13. The validity of this contract will be for a period of one year from date of commencement and extendable for another one year at the sole discretion of STC on the same rates, terms & conditions, subject to satisfactory performance of the obligations under the contract by the contractor. If, however, the performance is not found to be satisfactory during the contract period, the contract can be terminated at any time by serving 15 days notice in writing and security deposit shall be forfeited.
- 14. The rates quoted by the tenderers shall be valid for acceptance for a period of **90 days** from the date of opening of the tender.
