TENDER NOTICE DETAILS

Tenders are invited from reputed company/agency/contractor who had executed similar type of works in CPWD, PWD, BMC, PSU, Semi-Govt. departments for repair work of weighbridge (Capacity 50 MTs) installed at STC's installation at Muzawar Pakhari Road, Mallet Bunder, Near Wharf ferry (Bhau cha dhakka), Mumbai - 400009. Tender Form along with detailed terms & conditions may be collected directly from STC's branch office at Mumbai, or downloaded from www.stc.gov.in, www.tenders.gov.in and www.eprocure.gov.in

SCOPE OF WORK:

1. Dismantling of old Ramps on both sides of weighbridge and disposal of the debris.
2. Construction of new Ramps on both sides (length 12 Mtrs. on either side and width of 3.30 Mtrs.) (14 mm Steel bar is to be used along length (Horizontal) and 12 mm towards breadth (Vertical))
3. Old plate cutting, new plates fabrication and erection – Installation of C' channel (3.30 Mtr on either side).

The scope of work mentioned above are only brief description, bidders or its representatives are advised to visit the installation to have a clear and conspicuous understanding of the job before participating in the Tender. Any such visit should be conducted with prior advance intimation to STC Mumbai office. For intimation bidders are advised to write a mail to vpk@stc.gov.in and get required permission.

PLEASE NOTE THAT BIDS SUBMITTED WITHOUT SITE VISIT WILL NOT BE ACCEPTED.

Eligibility Criterion for participants:

1. Companies/Firms/Individual should be in existence for over 3 years in the business of similar civil work. Registration certificate should be attached with the Tender.
2. The Firm/Company/Individual should have a previous contract/experience of dealing with a Government Department/Public Sector Undertaking for similar repair work for a value of not less than Rs. 1,00,000/- in past two years (i.e FY 2012-13 or later). The company should furnish its contract/order documents from Government Department/Public Sector Undertaking executed in last two years.

III. COMPLETION PERIOD: Job as described above under scope of work (dismantling of existing ramp, casting of concrete and curing and strengthening of concrete) should be completed within 30 days after issuance of work order.

Time is the Essence of the contract:-

Time is the essence of the contract and the party shall ensure that all the obligations under the tender are completed within the agreed time schedule. The company/agency/contractor shall be solely responsible for all the delays including delays caused by their vendors. In case of delay in progress of the works STC reserves the right to forfeit the EMD, withhold the payment, cancel the contract unilaterally or complete the work departmentally or by engaging another agency at the cost and risk of the supplier.

If the contractor leaves the job in between, EMD will be forfeited and STC will take the custody of material lying at the site. The contractor can not claim any amount towards these materials. STC will also forfeit the payment of the part of work completed before abandonment of the work.

IV. PENALTY :-

Penalty at the rate of 0.5%(half percent) per day on the delayed period, shall be imposed for the work not completed within the mentioned period (30 days).

V. Submission of bids

Tender in prescribed format complete in all respects (**each and every page of the Tender document must be signed and stamped**) accompanied with documentary proof (as per eligibility criterion) and EMD of Rs. 40,000/- should be **dropped in the box kept at the reception of the STC Mumbai office on or before 11:00 IST on 27.01.2016.** The STC of India Ltd. shall not be liable for any delay in submission of the Tender documents due to postal delay or any other reasons.

1. The Tender document shall be submitted in two parts i.e.

Part-1:- Qualifying/pre requisite bid (as per Annexure – I) along with EMD of Rs 40,000/- and one set of STC'S Tender Document duly Signed & stamped on each page as token of acceptance of all "Terms & Conditions' mentioned therein (in sealed envelope)

Part-2:- Price bid as per Annexure II in separate sealed envelopes super scribing the respective (Qualification and Price bid) on both the envelopes.

Both the envelopes should be kept in another envelope super-scribing the Tender notice number and date.

2. The part-1 pre qualifying bid shall be opened in the presence of the bidder or their authorized only one representative (if they wish to remain present) in the office of STC Mumbai on the scheduled date and time (i.e on 27.01.2016 at 11:30 IST).
3. **The price Bids of those eligible bidders who qualify only in the pre qualifying bids shall be opened.** The exact date, time and venue of opening of Price Bids of the eligible bidders will be intimated through Fax/e-mail/phone/Courier service. **The offers should be valid for 7 days from the date of opening of the Offer.**

VI . Payment Terms: Payment will be made after satisfactorily completion of the work (duly certificated by the committee formed by STC) and within 15 days after submission of the bills. No advance will be paid. No escalation on any account shall be paid under any circumstances.

VII. Other Terms and Condition

1. All corrections/overwriting made while filling the quotations must be authenticated by the bidders.
2. Each quotation document is required to be signed by the bidder in token of his/their having acquainted himself/themselves with the Quotations Notice and Terms & Conditions. The rates quoted in the quotation should be firm and for all heights and levels and inclusive of all charges of materials, scaffolding, tools and plants, labour and fluctuations in the market rates, VAT, Service Tax, sales tax, excise duty, octroi and other taxes etc.
3. Bid should be accompanied with an EMD of Rs. 40,000/- (Rupees Forty Thousand only) through Demand Draft / Banker's cheque in favor of **"The State Trading Corporation of India Ltd."** In case the TENDER is not awarded the EMD so submitted by unsuccessful Bidders will be returned by STC within a fortnight from the date of award of the TENDER. EMD deposited with STC will not be entitled for any interest.
4. The offer complete in all respects along with EMD in sealed envelope addressed to Branch Manager, The S.T.C. of India Limited, **B-1-201, MARATHON NEXTGEN INNOVA, OPP PENINSULA COR. PARK, LOWER PAREL (W) MUMBAI-400013** **should be dropped in the Tender box kept at the above address latest by 11:00 hrs on 27/01/2016.** Offers should be submitted as per price bid format provided at **Annexure-II**.
5. Bids are to be deposited for LUMP SUMP work. Bidders are requested to submit the bid only after visiting the installation to have a clear understanding of the job. No compensation will be paid on account of reduction in quantity of any item of work. Payment shall be made on LUMPSUM basis only. No escalation on any account shall be paid on the

quoted rates during the period of contract and also during the duly sanctioned extension of time, if any.

6. The work shall not be considered as complete until the Committee constituted by STC has certified in writing that the same has been completed. Completion certificate will not be issued until the contractor shall clear the site of all malba, debris, scaffolding, surplus materials and huts etc. and remove all dirt and dust from the site.
7. The contractor shall acquaint himself with the site conditions and make his own arrangements for storage of materials at site. No material shall be supplied departmentally.
8. The quality of materials to be used shall be got approved from the Committee before execution of work. The contractor will rectify the defects pointed out to him by Committee and shall remove from the site all the rejected materials immediately.
9. The contractor will be fully responsible for any injury or accident to any person(s) employed by him, to the residents and for any damage to any structure or any part of the property which may arise due to operation/negligence of the contractor or its workers while executing the work.
10. All applicable taxes will be deducted from the final bill as per prevailing rates.
11. The rates quoted by the bidder shall be valid for acceptance for a period of 07 days from the date of opening of the quotation.
12. The rates shall be quoted only as per Annexure -II and each page of quotation shall be signed. Any cutting or overwriting is not permitted.
13. The bidder shall not sublet the work to other contractor.
14. No condition/deviation which is either additional or in modification of quotation conditions shall be included in the bid/ quotation submitted by the bidder. If the quotation contains any such condition on deviation from the tender conditions, the quotation will be rejected. STC's decision in this regard shall be final and binding.
15. In the event of the quotation being submitted by a partnership firm, it must be signed by each partner thereof, and further it must also disclose that the firm is duly registered under the Indian Partnership Act, 1932.
16. The contractor upon award of the work shall comply with all the required statutory provision e.g. Payment of Wages Act, Apprentice Act, Workmen's Compensation Act, Contract Labour (Regulation & Abolition) Act, Industrial Disputes Act, Maternity Benefit Act, etc. and the rates made there under from time to time. If any claim, on account of non-compliance of the above laws by the contractor arises against the STC, the bidder shall indemnify the STC. The Committee shall have the right to deduct from the money due to the contractor any sum required or estimated to be required for making good the loss suffered by a worker or workers.
17. The interested party should not have been blacklisted/ banned for participation in Tender/EOI by Govt. of India or by any Govt.

undertaking. The party has to submit an UNDERTAKING to this effect along with quotation on their letter head.

18. Once the bid is submitted, it will be deemed that the bidder has satisfied himself/herself with the terms and conditions of the TENDER and will abide by the same.
19. The bidder shall keep STC indemnified at all times against any claim/liabilities/proceedings etc from any third party or otherwise arising out/of in connection with TENDER.
20. STC reserves the right to accept or reject in full or in part any or all Tenders at its absolute discretion without assigning any reason whatsoever.
21. STC do not bind themselves to accept the lowest or any Tender or to give any reasons for their decision.
22. The applicant hereto agrees that the courts and tribunals at Mumbai shall have exclusive jurisdiction to settle any or all disputes which may arise out of or in connection with this TENDER. All disputes arising out of this TENDER shall be decided in accordance with the laws of India.

Any CORRIGENDUM/ REJOINDER/ADDENDUM will be published on the STC's website.
