- 3. Part-II Price bid received through e-tender will be opened after evaluation of Part I tender.

3 OTHER CONDITIONS:

- (a) The person or persons signing the e-tender shall state the capacity in which he / she / they / it are signing the e-tender. If an individual makes any e-tender, it shall be signed with his full name and address. If it is made by a Firm, it shall be signed by all the partners of the Firm or by a partner of a Firm duly empowered or authorized to do so and the authorization / Power of Attorney should also be enclosed.
- (b) If any e-tender is made by a Corporation / Company / Coop Society, it shall be signed by a duly authorized officer, who shall produce with his tender satisfactory evidence of its corporate existence before the contract is executed.
- (c) Either the tenderer or the person duly authorized by the tenderer alone will be allowed to be present at the time of opening the tenders / negotiation.

4 VALIDITY OF OFFER:

Tenders should keep their offer valid for 90 days from the opening of the Part-I tender. Tender containing any other validity date prior to 90 days from the opening of the Part-I tender are liable to be summarily rejected.

5 i) ELIGIBILITY OF TENDER:

The tender will be evaluated based on the following factors in addition to the price criteria.

- (a). The tenderer should have the experience of supplying 50 Kg "A" Type new bale gunnies to sugar mills/ Government / Public Sector undertakings / Co-operatives or reputed organizations in any two Accounting year during the years 2014-15, 2015-16 2016-17 & 2017-18.
- (b) The Average Annual turnover of each of the last four Accounting years viz. 2014-15, 2015-16 2016-17 & 2017-18 should be above Rs.20 Crores duly certified by the auditor.
- (c) The Production capacity should be a minimum of 15,000 Tonnes of Jute goods per annum.
- (d) Performance / Quality certificate obtained during any two financial years from 2014-15 with reference to clause 9 section I of the tender documents should be submitted for supply of 50 Kg "A" Type new bale gunnies from any sugar mills / Government / Public sector undertakings / Co-operative or reputed organization.
- (e) The performance of the tenderers during previous years regarding observance of quality and other terms and conditions of the contract.
- (f) The federation reserves the right to increase the quantity up to 25% additionally at the tender rate as per Tamilnadu Transparency in Tender Act.

ii) **EVALUATION OF e-TENDERS**

1 The evaluation of price e-tender shall include all taxes and duties as a part of the price.

(iii) Sample Test Report

The Sample jute gunnies are to be sent for testing as per clause No:9 (Specification). If the samples fails and not upto the specification as per clause no: 9 the tender will be rejected. The sample test charges will be deducted from the EMD amount paid by all prospective tenderers.

6 EARNEST MONEY DEPOSIT:

EMD of **Rs.5,00,000/-** (Rupees Five Lakhs only) should be sent through off-line (not through portal) RTGS to Tamil Nadu Coop. Sugar Federation Ltd. account clearly mentioning the name of the party as per the detail given below.

Tenders without the EMD will be summarily rejected provided that any category of tenderers specifically exempted by the Government from the payment of EMD are not required to make such a deposit subject to the production of documentary evidence. In the case of SSI units claiming exemption for payment of EMD, the SSI certificate having current validity should be submitted with tender. No letter correspondence will be entertained. In case of non submission of SSI certificate having current validity the tender will be rejected. In case of SSI units claiming exemption from payment of EMD an undertaking in a stamped paper valued at Rs.20/should be furnished for making good the loss, if any, sustained by the sugar mill for breach of conditions warranting the forfeiture of EMD.

In the case of successful tenderers, the Earnest money Deposit remitted by them will be refunded after deduction of the sample testing charges and only after satisfactory completion of the supply of the entire ordered quantity and replacement of rejected 50 Kg "A" Type new jute bags with inner liner by new bale gunnies and shortages to all the sugar mills. In case of unsuccessful tenderers, the Earnest Money Deposit after deduction of the sample testing charges will be refunded within one month from the date of finalising the tender. The EMD carries no interest. The amount remitted towards EMD is liable to be forfeited, in case, the tenderer resiles from their offer after submission of the tender or after the acceptance of the offer by the Tamil Nadu Coop Sugar Federation.

7. SECURITY DEPOSIT:

The successful tenderer should remit a security deposit of 5% of the total value of the order subject to a maximum of Rs.30/- lakhs by way of RTGS/ Demand Draft / Banker's Cheque drawn on Nationalised Bank in favour of Tamil Nadu Cooperative Sugar Federation Ltd. within 7 days from the date of receipt of the first communication of acceptance of tender from the Tamil Nadu Cooperative Sugar Federation. Only after receipt of Security Deposit, orders for fixation of rate contract will be issued by the Tamil Nadu Coop Sugar Federation Ltd. The value of each gunny bale will be considered based on the average rate arrived at from out of the rates declared by GTA for the month in which the tender was floated for the purpose of remitting of supply towards security deposit. Any failure to value of the cost remit the security deposit will entail termination of the contract besides In addition, the Tamil Nadu Coop Sugar Fedn Ltd will be forfeiture of EMD. entitled to recover the consequential loss if any sustained by the Tamil Nadu Coop Sugar Fedn Ltd from the tenderers due to purchase made in re-tender or in any other manner. The Security Deposit will be refunded only after satisfactory completion of the supply of the entire ordered quantity and replacement of rejected 50 Kg "A" Type new jute bags with inner stitched liner by new bale gunnies and shortage to all the mills. The security deposit carries no interest.

8 BRANDING AND PACKAGING:

The bags are to be supplied UNBRANDED and should be FLAT PACKED in wrapper gunny sheet, well pressed in 5 iron stripes bound bale containing 500 Nos of 50 Kg "A" Type jute bags with stitched inner liner new bale gunnies duly marked and despatched in covered vehicles. Despatch shall be made strictly on "freight paid" basis only at the seller's risk. The 50 Kg "A" Type new bale gunnies with stitched inner liner shall be so made that the contents are protected from stains, oil, water or any other damage in handling. Bags should not stick with one another and should easily be separable. The packing must conform strictly to BIS specification **IS 2873:1991**.

9 SPECIFICATION

The tenderer should supply 50 kg "A" Type jute bag having outside length 90 CM and Out Side Width 61 CM having Weight of sack alone 675 gms with all other specifications as prescribed by BIS (IS:15138:2002) and subsequent amendments made thereon. The sack shall be provided with a Liner of food grade Virgin confirming to IS 10146. The width of the Loose Liner shall be atleast 20 mm more than the width of the sack and the length of the Liner shall be atleast 50 mm more than the length of the sack. Thickness of the loose liner, when tested in accordance with A2 of IS 2508 shall be 40 μ m +/- 10%. The bottom seam of the loose liner shall be atleast 25 mm from the bottom Edge. The mass of the loose liner shall be 35+/- 2 gms. The Liner shall be free from Pin holes, patches, tears, blisters and any other visible defects. The inner loose liner shall confirm to clause 3:3:3 of IS 14968:2001 and amendment No:1 March 2005 on clause 3:3:3. The Liner shall be stitched with Gunny bags

Tenderer should ensure the supply of quality 50 kgs A type new Jute bags with stitched inner liner. If there is any deviation in mass, below the tolerance, payment will be reduced on prorata basis. Actual weight of the gunnies received at Mills / loadwise will be taken as basis for deciding whether gunnies are as per specification prescribed by the BIS (IS 9113:1993) and subsequent amendments made thereon, in respect of mass per gunny.

Tenderer should ensure the supply of quality 50 kgs A type new Jute bags with stitched inner liner bags. For the purpose, a specific undertaking should be given by the successful bidder. The gunny bags are to be sent for testing from each consignment and payment will be made only for the gunnies received as per the specification as per clause No:9 above. If the quality is not up to the specification as per clause no: 9 above, the supplier has to take back the entire load of rejected gunnies within 7 days from the mills premises. The test charges for sample gunnies sent for analysis will be recovered from the supplier. The 50 kgs "A" type new Jute bags which conform to the above specification alone will be accepted. In

case, 50 kgs A type new Jute bags supplied are found not conforming to the above specification, the same will be rejected by the mills and notice will be sent to the successful tenderer by the Sugar Mill requiring them to supply gunnies as per the specification. Even after giving two such notices, if the supplier fails to supply gunnies which conform to specification as per clause No: 9 above, action will be taken to blacklist the supplier and to disqualify the tenderer to take part in the future tenders and also the Tamil Nadu Coop. Sugar Federation. and / mill reserves the right to cancel the order for the quantity of gunny bags remaining to be supplied and procure the same at the prevailing market rate from the other sources at the risk and cost of the supplier. In that event the loss sustained, if any, by the sugar mills will be recovered from the supplier. The test report of the laboratory with regard to the conformity of the specification criteria is final and the tenderer should accept the same without raising any dispute.

Apart from the above test report the mill shall also undertake 100% checking of the entire gunny bags at the time of segregation of the gunnies. Based on the segregation report the mill shall deduct the cost of the defective bags and shortage bags from the balance 10% / subsequent payment. (Please refer payment condition at clause No. 17)

10 MARKING:

The 50 Kg A Type Jute bags with stitched inner liner shall be marked as prescribed in IS 2873: 1991 and subsequent amendment made thereon, if any. Each consignment shall be accompanied with actual test certificate.

11 SOURCE OF SUPPLY:

Supply shall be effected only from the jute mills manufacturers. The manufacturers shall be responsible for quality and timely supply of new 50 kgs A type new Jute bags with stitched inner liner bale gunnies to the sugar mills concerned. All bales should bear ISI marking before despatch. Gunnies manufactured in India alone should be supplied.

12 PRE INSPECTION:

Member sugar mills or Tamil Nadu Cooperative Sugar Federation have the right to pre-inspect the materials either by their Officers or thro' any authorised inspection agency to ensure that the gunnies manufactured are in conformity with the specification fixed by the BIS. The supplier should offer all facilities for the inspection prior to despatch. However, the supplier can not absolve of their responsibility for quality supply just because of the prior inspection. Only final inspection at site of the concerned sugar mills will be binding on both the parties.

13 TRANSIT INSURANCE:

The 50 Kg "A" Type new bale gunnies despatched should be covered under Transit Insurance upto the delivery at the godown of the Sugar mills concerned. The Tamil Nadu Cooperative Sugar Federation / Sugar Mills will not be responsible for any loss or damages during transit. It is the sole responsibility of the supplier to prefer claims with the Insurance Company for settlement of cost of loss / damages if any. The purchaser shall recover the amount on account of damages / shortage from any pending dues, EMD and Security Deposit of the supplier.

14 QUANTITY AND DELIVERY:

- a) The quantity mentioned in the tender for each mill is only an approximate and the concerned sugar mills will place firm order for 50 Kg "A" Type for each month requirement 45 days in advance. The supplier is to ensure the delivery of the gunny bags within 30 days from the date of receipt of the supply schedule intimation from mills. The sugar mills/Federation reserves the right to modify the delivery schedule which is binding on the supplier.
- b) The quantity required is approximately 13.39 lakhs pieces of 50 Kg 'A' Type Jute bags with stitched inner liner new bale gunnies. The respective sugar mills will place orders for the exact quantity required. The Tamil Nadu Coop. Sugar Federation and the concerned mills hereby reserves the right and shall be at liberty to reduce or increase the quantity of bags to be supplied during the period of contract remaining in force.

15 DESPATCH DETAILS:

The supplier should furnish the details of despatches made at their end to the respective mill by fax /email under copy to Tamil Nadu Cooperative Sugar Federation.

16 PRICE:

The tenderer shall quote OPEN PRICE for 50~kgs A type new Jute bags with stitched inner liner as per specification given in clause : 9 . The tenderer should quote the rates for 100~nos of 50~Kg "A" Type jute bags strictly in the format prescribed.

- (1) a) Transport charges for delivery at millsite
 - b) Taxes and duties applicable on transport charges.
- (2) Insurance
- (3) Other Charges to be furnished Head wise with explanatory note for each Head during negotiation.
- (4) Percentage of applicable taxes and duties.
- (5) No single rate should be quoted. If quoted so, the same will be rejected. The lowest price will be determined on the basis of the rates offered by the tenderers for the above items.

The open price of 50 Kg "A" Type new jute bags with stitched inner liner bale gunnies for each month's delivery shall be determined on the basis of average price of GTA for 50 Kg "A" Type new bale gunnies (OR) Rate quoted by the Jute Commissioner for B.Twill - A Type Average Price on whichever is lower basis in Kolkata's daily ruling one month prior to the month of delivery , e.g. for August, the price average rate of July month will be applicable.

Variation if any, in the Government levies between the date of tender and scheduled date of delivery shall be settled between the purchaser and seller subject to the production of documentary proof.

If supplies are delayed by the supplier, the price payable will be the lower of the two i.e. one pertaining to the scheduled month of delivery and the other to the actual month of delivery e.g. If the delivery schedule for the month of July is made during August, the ready average rate of previous month of June or July whichever is less will be paid.

If however the supplies are delayed under Force Majeure conditions, the price payable will be applicable as per scheduled month of delivery and not the actual month of delivery subject to the conditions that the supplier should give immediate information by RPAD to the mill concerned and Tamil Nadu Coop. Sugar Federation with documentary proof about the expected delay in supply due to circumstance covered under Force Majeure condition. Tamil Nadu Coop. Sugar Federation reserves the right to examine the request of the suppliers in this regard and take appropriate action. The decision of the Tamil Nadu Coop. Sugar Federation will be final and binding on the purchaser and seller.

If the Tenderer supplies 50 Kg "A" Type new bale gunnies of same specification to any other Mill at a lesser rate, while applying GTA 50 Kg "A" Type new bale gunnies rate (OR) Rate quoted by the Jute Commissioner for B.Twill - A Type Average Price on whichever is lower basis in Kolkata's daily ruling one month prior to the month of delivery, the same will be made applicable to Cooperative & Public Sector sugar mills in Tamil Nadu.

17 PAYMENT:

90% payment against the valid invoices will be made by the sugar mills concerned within 15 days of receipt of the goods at mill site, based on the Lab test report for each load which conforms BIS Specifications of gunnies. Read with Clause No.9 (Specification) of the tender document. Payment will be made by means of A/c payee cheque. If the supplier insists for Demand draft, the bank commission will be borne by the supplier.

The sugar mills conducting any test at outside lab the testing charges will be deducted from the supplier bill. If the quality is found inferior the sugar mill reserves the right to reject the particular load of gunnies and payment will not be made.

The balance **10%** payment will be made by the sugar mills with in 15 days from the date of completion of crushing operation for this sugar season with new consideration to all other terms and conditions pertaining to payment in the tender documents.

In the case of Kallkuruchi 1 and Kalluruchi 2 CSM the balance 10% payment for the main season with in 15 days from the date of completion of crushing operation for this main sugar season with new consideration to all other terms and conditions pertaining to payment in the tender documents.

For the Special Season the balance 10% payment will be made with in 15 days from the date of completion of special crushing operation for this sugar season with new consideration to all other terms and conditions pertaining to payment in the tender documents

18 TAXES AND DUTIES:

The tenderer should give an undertaking in the format in annexure v to sugar mills to reimburse demand of additional levy at the time of assessment of sugar mills by respective authority.

19 LIQUIDATED DAMAGE AND PENALTY:

- i. If the supplier fails to deliver the consignment to the sugar mills as per clause 14 above, liquidated damages at the rate of 2.5% of the value of delayed supplies per completed week subject to a ceiling of 10% will be recovered from the supplier. This will be deducted from the bills while making 90% payment.
- ii If the delay extends beyond 4 weeks, the purchaser shall have the option to cancel the defaulted quantity and to procure the same quantity from other sources at the risk and cost of the supplier, in order to run the sugar mills un-interruptedly In that event, the supplier is liable to pay to the purchaser, the differential cost including all components and other expenses that would be incurred by the purchaser in respect of this transaction.

20 FORCE MAJEURE CLAUSE:

In case the purchaser is not in a position to accept supplies as per terms of delivery due to any one of the following reasons, the purchaser reserves the right to suspend normal supply until the position returns to normalcy or even to terminate the contract if the circumstances are beyond their control.

- i) Strike
- ii) Lock-out
- iii) Accumulation of stocks or non availability of storage space
- iv) Power cut
- v) Decline in production or any other forces or natural calamities which affect the production of the purchaser.

The supplier should supply gunnies without any delay except due to natural calamities. The supplier has to build up the required stock of A-Twill gunny bags and ensure to supply the entire seasons requirements irrespective of strike, lock-out and other reasons except natural calamities.

In the event of delay lasting over fifteen days, the Federation reserves the right to cancel the order / contract without any compensation whatsoever and / or any consequential loss etc.

21 FORFEITURE OF EMD / SECURITY DEPOSIT:

In the event of failure to supply the ordered quantity of 50 Kg "A" Type new bale gunnies as per the specification or for violation of terms and

conditions of the tender, the EMD and Security Deposit remitted by the tenderer will be forfeited. In addition to this, the Tamil Nadu coop Sugar Federation reserves the right to disqualify the tenderer to participate in future tenders or blacklist the tenderer. The Tamil Nadu Coop Sugar Federation Ltd also reserves the right to purchase the undelivered quantity through re-tender at the risk and cost of the successful tenderers apart from collecting the consequential loss **along with interest** or by adjusting the loss from the bills payable to the supplier.

22 REPLACEMENT AND REMOVAL OF REJECTED BAGS:

(A) The 50 Kg "A" Type new bale gunny bags with stitched inner liner received that are not in conformity with the specifications as per clause no.9 of terms and conditions will be rejected by the purchaser. The purchaser will open the bales and report the details of rejections if any to the supplier strictly within 30 days from the date of receipt of consignment at mill site. The rejected 50 Kg "A" Type new bale gunnies as reported by the sugar mills should be replaced by the supplier in the form 50 Kg "A" Type jute bags new bale gunnies with the requisite specification within a period of 30 days from the date of receipt of intimation from the sugar mills, failing which penalty will be levied as per clause 19 of the terms and conditions. The supplier shall arrange for mending the stenciled damaged bags and the cost of mending shall be borne by the supplier. In the case of replacement of defective / damaged 50 Kg "A" Type jute bags by the supplier at later date beyond 30 days, the value of defective 50 kg A. Type new bale gunnies will be adjusted by the sugar mills at the rate applicable for the original supply or the rate applicable for the month in which it is replaced whichever is advantageous to the sugar mills.

If the cost of defective / damaged 50 Kg "A" Type new bale gunnies with stitched inner liner exceeds the 5% retention amount, the difference will be recovered from the suppliers' next bill itself.

If the supplier continues to supply defective 50 Kg "A" Type new bale gunnies with stitched inner liner, the purchaser has the right to cancel the remaining portion of quantity and procure the same from outside at the then prevailing market rate. In that event, the loss sustained, if any, by the purchaser will be recovered from the supplier.

In case of any dispute as to whether a 50 Kg "A" Type new bale gunny bag with stitched inner liner is defective / damaged or not the decision of the respective sugar mills shall be final.

In the event of non removal of defective / damaged bags, the mills have liberty to dispose of such goods in such manner as they deem fit. The sale proceeds will be credited to the account of the supplier after deducting the expenses incurred for disposal and replacement. The supplier will not be entitled to claim any loss / damage occurred by such sale. The decision of the sugar mill shall be final and binding in all such cases. In case, the purchaser is unable to dispose of rejected 50 Kg "A" Type new bale gunnies of the supplier, the supplier is bound to pay godown charges to the purchaser until the goods are removed.

If any amount is left un-recovered after the above adjustment, the same will be recovered from pending dues, EMD and Security Deposit of the supplier.

(B) Response for Telephone / Fax message from Tamil Nadu Cooperative Sugar Federation Ltd and Sugar Mills

The Tenderer / Authorised person when contacted over Cell phone / landline telephone numbers or fax number by Tamil Nadu Co-operative Sugar Federation or Sugar Mills for any complaints / clarification regarding quality and quantity of their products supplied to the sugar mills should respond immediately. Any lapse of response and thereby if any loss is incurred to Tamil Nadu Co-operative Sugar Federation or Sugar Mills, the loss amount will be recovered from their EMD or Security Deposit amount or through other means in addition to blacklisting the Firm from attending the future tenders in Tamil Nadu Co-operative Sugar Federation and Sugar Mills.

23. AGREEMENT:

The contract will be on rate contract basis and the firm order will be placed by the individual mill based on the rate finalised by the Tamil Nadu Co-operative Sugar Federation.

The supplier should execute an agreement with the individual mill for fulfillment of the contract in the non judicial adhesive stamp paper of value as per the law in the prescribed form within 10 days from the date of receipt of purchase orders from the mills. In the event of failure to execute the agreement within the time prescribed, the EMD and Security Deposit amount remitted by the tenderer shall be forfeited. Further, the Tamil Nadu Coop Sugar Federation Ltd reserves the right to collect the consequential loss if any sustained by the member mills along **with interest** from the tenderer and the tenderer is bound to pay the same on demand.

24 JURISDICTION OF COURT:

For any dispute arising out of this contract, the jurisdiction will lie with the court in whose territory the mill is located.

25. APPLICABILITY OF TAMIL NADU TRANSPARENCY IN TENDER'S ACT & RULES

The Tamil Nadu Transparency in tenderers Act 1998 and the Rules made thereunder for the time being in force shall apply to the tender
