<u>E- Tender Notice for inviting Trade Margin quotations from the empanelled Business</u> Associates through Central Public Procurement Portal (CPPP) for Participation in APO's (Army Purchase Organisation) tenders for supply of 26400 MTs of various varieties of pulses (as per Appendix –E & G) of APO Tender Notice- RFP NO:62701/0/24/RFP/2017/APO (PUR-III) DATED 07.12.2016 which is closing on 02.01.2017 at 16:00 HRS

Against the subject tender floated by APO, the empanelled Business Associates of STC are invited for participation in said tenders of APO as our backup supplier on the following terms & conditions:

NOTE: Kindly note the said tender is exclusively for participation of parties empanelled with STC for supply of Pulses.

## A. APO terms-Documents & Security to be provided as per the requirements of APO tenders terms

1. The Backup supplier to furnish the required EMD for APO tender participation on behalf of STC in the form of a Fixed Deposit Receipt (in favour of "PCDA NEW DELHI") payable at Delhi or Bank Guarantee from any of the public sector banks or a private sector bank authorized to conduct government Business as per Form-13, i.e, as per Appendix-F of aforesaid RFP dated 07.12.2016. EMD is to remain valid upto 1<sup>st</sup> April, 2017.

2. Upon successful award of tender, the backup supplier to either furnish 10% Security Deposit (SD) to APO in line with APO format at Appendix-J, through STC as per the terms and conditions of the above referred RFP dated 07.12.2016, or can furnish 10% SD/BG to STC within 5 days of award of tender (AT) by APO to STC to enable STC to prepare and submit 10% SD/PBG to APO.

3. Undertaking from all the participants that the terms & conditions of above referred APO tender are accepted by them and same shall be strictly complied with.

4. All tender terms and conditions are to be accepted by the backup supplier.

## B. <u>Additional Security Deposit to be submitted exclusively to STC and terms thereof:</u>

- 1. Submission of Performance Bank Guarantee, in STC's prescribed format (exclusively for STC) for the 5% awarded contract value towards Guarantee for performance.
- 2. On dated cheques in favour of STC for the balance exposure i.e 95% of tender awarded value.
- 3. The stocks of various varieties of Pulses to be arranged by the parties strictly complying with the DEFENCE FOOD SPECIFICATIONS 2016 (Temporary) specifications, packing etc., as per tender terms. The copy of tender notice for supply of pulses to armed forces is placed below at Annexure I. For further details, kindly refer aforesaid RFP dated 07.12.2016 and other tender details at the Central Public Procurement Portal (CPPP) of NIC at https://eprocure.gov.in/eprocure/app.

The shortlisted backup supplier should submit an undertaking that in the subject tender they shall be exclusively participating only through STC and will not directly or through any other company participate in the said tender. If the same is found at a later date, the said supplier will be debarred for further tender participation through STC under intimation to all state and central government departments.

**C.** The party who quotes highest trade margin in percentage terms (subject to minimum 1%) will be considered. The Trade Margin and quantity offered for aforementioned APO tender need to be filled in the prescribed format at Annexure-II.

D. The bids which are not agreeing to the terms &conditions of the subject APO Notice, RFP and quotations with conditions shall be summarily rejected.
