Notice for inviting Price quotations from the empanelled parties for participating in tender for supply of 300.0 Kgs Cardamom (8mm); 200.0 kgs Black Pepper(4.5mm); 100.0 Kgs Cloves(Janjibar best) and 100.0 kgs Cinnamon (Role type) inclusive of all taxes ,transportation(FOR Udaipur) & transit insurance.

Terms and Conditions:

- 1. STC at its own discretion may increase or decrease the quantity mentioned above.
- 2. Payment: Within 30 days from the date of purchase order, 100% Payment by RTGS shall be made by STC after complete delivery of items at end-user premises by your company and receipt of acceptance certificate from the end-user by STC.
- 3. **Dispatch**: We need immediate deliveries, therefore, items should be dispatched within 5 days from the date of purchase order.
- 4. **Transit Insurance**: The goods to be 110% insured of the sale value by the supplier. Price quoted should be all inclusive.
- 5. Packing: Packing should be done in gunny bags (50 Kg. each).
- 6. A Survey Report regarding the quality and quantity from a reputed surveyor is required.
- 7. **Supplier** has to take entire responsibility for the **quality and quantity** (as per Surveyor report) variation of all above items including replacement at their own cost and STC shall not accept any responsibility, liability and any claim from our end-user, if received after supply.
- 8. Supplier shall quote for all the four items. Any supplier quoting for less than four items shall be rejected.
- 9. Quotations shall be compared on total price basis not per item basis. The L1 rate will be decided on total price basis quoted for all the four items. The Price quotation to be quoted in the prescribed format at Annexure-I.
- 10. STC reserves the right to accept or reject any offer of EOI without assigning any reasons whatsoever. The decision of STC in this regard shall be final and binding on all participating suppliers
- 11. Bids which are not agreeing to the terms &conditions of the subject notice and quotations with conditions shall be summarily rejected.
- 12. Closing time & date of Price Quotation: The empanelled parties are requested to submit their Price Quotation through Central Procurement Portal (www.eprocure.gov.in) latest by 1600 HRS on 23.09.2016
