For Appointment of Associate for Construction and utilization of Tanks for Storage of EDIBLE GRADE OIL/ NON EDIBLE NON FLAMMABLE OIL at plot no 114 to 117 Chamar Godi (Near ferry warf), Mallet Road Mumbai 400 009.

### ABOUT US

THE STATE TRADING CORPORATION OF INDIA LIMITED (STC), incorporated under the Companies Act, 1956 and having its registered office at Jawahar Vyapar Bhawan, Tolstoy Marg, New Delhi – 110 001 is a Government of India Enterprise under the administrative control of Ministry of Commerce & Industry, Department of Commerce. STC is a premier international trading organization of India with experience of handling international and domestic business for over five decades and has been handling import and export of various kinds of products and commodities including various types of Liquid Bulk Cargo.

STC, Mumbai branch is having a vacant plot measuring an area of 1111.17 square mtrs. (taken on lease from MBPT) at plot no 114 to 117 Chamar Godi (Near ferry warf), Mallet Road Mumbai 400 009, next to Mumbai Port. STC hereby invites Expression of Interest (EOI) from reputed Indian/ foreign companies who will construct tank(s) to utilize for storage of liquid cargo viz. Edible Grade Oil / non edible non flammable oil. It is mentioned that the cargo would be received in tanks through UGPL which is directly connected from 10, 11 and 12 ID for discharge of the cargo from the vessel as being done in the adjacent installation of STC. Preference will be given of Edible Grade Oil, however reputed Indian/ foreign companies who intend to store Non Edible Non Flammable Oil are also invited to participate.

**Representatives of the bidder are advised to visit the plot to have a visual inspection of vacant plot which is adjacent to STC's oil installation at Mallet Bunder. Any such visit should be done with prior advance intimation to STC Mumbai office.**

### SCOPE OF WORK

1	To construct the Tank(s) at the Vacant plot either by themselves or by hiring third party at their cost and risk	STC will assist to find a third party who could undertake the job of construction
2	To get all the required NOC from concerned authorities for the construction of Tanks	STC will assist to get the NOC
3	To hire a consultant if required for the survey or feasibility study of the plot	STC will provide first hand information about the plot

It is explicitly mentioned that entire cost and expenditure towards construction of tank(s) (including survey or consultancy fee/ construction fee, construction of connecting pipeline etc) has to be borne by the Interested Party. The cost and expenses incurred towards construction of tank(s) will be adjusted with the monthly rentals which will be effected at prevailing market rate.

It is also made clear that the plot will be provided for storage of Edible Grade Oil / Non Flammable non edible Oil on co terminus basis, since the plot has been allotted to STC by MBPT (or for 10 years whichever is earlier) for construction of tanks and storage of liquid cargo.

The incurring cost in connection with construction of tank(s) will be jointly verified by STC and interested party and interested party have the option of hiring the consultants/ companies for consulting job etc.

#### **PREQUALIFICATION CRITERION**

The party must have knowledge of import/export and supplying of liquid cargo in India or abroad. The Party should also have resources to invest and undertake the job as mentioned in the Scope of Work above.

#### **OTHER TERMS AND CONDITIONS:**

1. The interested party has to submit solvency certificate from their Bank to show their credit worthiness for upto Rs.10 Cr. (Indian Rs. 10 Crore only) or equivalent foreign currency.
2. The interested party has to submit a satisfactory Credit Rating Report (not more than one year old) from any of the following international Credit Rating Agencies for direct submission to STC by the concerned agency in a sealed cover.
  - Dun & Bradstreet
  - Moody's
  - Standard & Poor
3. The interested party should not have been blacklisted / banned for participation in tender by Government of India or by any Government Undertaking for supply of Edible /Non-Edible/ Non-flammable oil or otherwise in India. The supplier shall have to submit an UNDERTAKING to this effect along with quotation.

4. The applicant shall keep STC indemnified at all times against any claims/ liabilities/proceedings etc. from any third party or otherwise arising out/or in connection with this EOI.
5. In case of violation of terms and conditions of the contents of the EOI, violation of statutory regulations, violation of local laws STC shall reserve the right to terminate the services provided to the prospective party may be added.
6. The applicants hereto agree that the Courts and Tribunals at Mumbai shall have exclusive jurisdiction to settle any or all disputes which may arise out of or in connection with this EOI. All disputes arising out of this EOI shall be decided in accordance with the laws of India.
7. Once the bid is submitted, it will be deemed that the bidder has satisfied himself/herself with the terms and conditions of the EOI and will abide by the same.

The terms and conditions given above are only illustrative and not exhaustive. A detailed agreement will be signed with the parties who will be awarded the tender.
